#### **DEROGATIONS FROM THE GENERAL IMPLEMENTING RULES**

Section 4, 'Specific contractual and administrative conditions' of these Tender Specifications (CSC/Cahier Spécial des Charges) holds the specific administrative and contractual provisions that apply to this public contract by way of derogation from the Royal Decree of 14.01.2013 or as a complement or an elaboration thereof.

# **1** Technical Specifications

# **1.1 Requirements for the services and the deliverables**

#### 1.1.1 Technical methodology

The Contractor shall provide the services and the deliverables as specified hereafter by applying a technical methodology, which factors in the following aspects.

#### 1.1.1.1. Background information

In June 2023, Uganda and the Kingdom of Belgium renewed their partnership and signed a cooperation agreement for 5 years (2023-2028). Under this framework, Belgium through Enabel, the Belgian development agency, is implementing a Uganda Country Portfolio with the overall objective of "Young people and women in Uganda develop into active, economically independent citizens in a sustainable society that respects human rights and ensures quality basic services". Two general objectives have been defined, which are articulated into the following two main pillars:

- General objective 1 (Pillar 1): "Young people, especially young women, acquire skills and find decent jobs or entrepreneurship opportunities in agriculture and the green and sustainable economy."
- General objective 2 (Pillar 2): "The right to safe and quality education and health care is more transparently ensured, in particular for vulnerable groups including children, girls and women, and refugees."

Implementation of Pillar 1, will follow an economic sector logic approach, with a focus on specific value chains in agriculture and the green economy<sup>1</sup> under the Green and Decent Jobs for Youth (WeWork) project which has 2 specific objectives (SO); one focusing on skilling and employability (supply side) and second, focusing on entrepreneurship and employment (demand side):

- **SO1:** Young people, at least half of whom are women, have access to high quality skills development that offers the prospect of green and decent jobs;
- **SO2:** Trained young people, at least half of whom are women, are guided and supported to find green and decent jobs or to start a successful business.

Six result areas have been designed to achieve the above specific objectives; namely:

**R1:** TVET, agriculture and the green economy are better promoted as employment pathways; **R2**: The provision of skills development is more equitable, qualitative, innovative, and demand-driven for increased employability;

**R3:** Work-ready youth have increased access to general employment services that connect them with decent work employers;

**R4**: Vulnerable youth, including women, have increased access to entrepreneurship promotion and support to set up small businesses;

**R5:** Selected enterprises are supported to engage in sustainable development for green growth and decent jobs, and

**R6:** The development of selected value chains in agriculture and green economy is improved.

The geographical focus includes regions of Albertine/Rwenzori and Busoga in the respective districts of Hoima in Albertine; Kasese, Kabarole and Kyegegwa in Rwenzori as well as Kamuli and Jinja in Busoga; inclusive of the respective cities and municipalities. In addition, the regions

of West Nile and Kampala comprising of the districts of Mukono, Wakiso and KCCA are covered under the EU funding framework.

During formulation, WeWork project strategic and operational framework was informed by key learnings from the successor Skilling programme - Support to Skilling Uganda (SSU) project (2015-2022). First, was the need for mindset change amongst the youth and community towards regarding skilling in TVET and agriculture as viable employment pathways to increase uptake and enrolment for both formal and short-term/nonformal skills development. Second, was the fact that in order to create impact of any skilling intervention, the skills development should be aligned to the skills gaps/needs of the employers (demand driven) thus resolving the skills mismatch issues. Indeed, the gap between the skills of Technical and Vocational Education and Training (TVET) graduates on the one hand, and the private sectors needs for qualified employees on the other hand remains significant. Graduates do not meet the skills and competences demanded on the labour market and are in many cases considered by the private sector as 'non employable'. This results into an insufficient supply of skilled labour with appropriate skills and competences, right work ethics and attitude; a situation that constitutes a major challenge for the private sector companies in Uganda in terms of loss of productivity and sustainability and attractiveness for future investments.

Therefore, it is against this background that Enabel is seeking for quality consultancy services to undertake the process of identification and articulation of the skills needs/gaps and potentials for meaningful self and paid employment opportunities as well as mapping relevant employers or private sector actors involved in skills development in priority sub-sectors.

# 1.1.1.2 General objective:

The overall objective is to conduct a labour market scan and training needs analysis that will be used to link/bridge the gap between the supply side (youth employability) and the demand side (self and paid employment opportunities) in relation to agriculture and green economy sectors for the Albertine/Rwenzori, Busoga and Kampala as well as West Nile regions.

Specific objectives are:

- i. Assess the potential job/employment/entrepreneurship/business opportunities on demand, by private sector actors for TVET (formal and nonformal) graduates in agriculture and the green economy sectors
- ii. Explore and recommend other emerging economic growth sectors/subsectors with clearly demonstrated and high potential for youth employment complementary to the agriculture and the green economy sectors
- iii. Identify relevant new or changing occupations anticipated in the green transition (green economy) and related skill gaps and training needs in initial and continuous TVET (upskilling, reskilling)
- iv. Determine current skill/competence needs, demanded by associated employers/private sector actors in agriculture and the green economy sectors
- v. Identify priority skills gaps and training needs in both formal and non-formal short-term training hindering youth to be able to engage in meaningful self and paid employment in agriculture and the green economy sectors

#### 1.1.1.3 Tasks of the assignment

The tasks shall be per Lot i.e. region as follows:

#### Lot 1: Albertine/Rwenzori region (Hoima, Kabarole, Kasese and Kyegegwa)

- **Task 1:** Conduct extensive literature review relevant to the scope of the assignment e.g. previous labour market studies as well as understanding Pillar 1 of the approved Enabel Uganda Country Portfolio 2023-2028 to be able to identify the relevant stakeholders to involve in the study such as training providers and trainees, private sector companies and businesses, farmer groups, cooperatives, traders and agro processing companies as well as relevant local government departmental heads (Education, Community Development, Production, Labour, Commerce etc.).
- **Task 2:** Conduct extensive secondary data and primary data gathering and analysis to identify the required employable skills and related gaps/needs within the different occupations/trades/courses in agriculture and the green economy sectors categorized into skills types and levels and with special attention to gender.

#### Lot 4: West Nile region (Arua, Yumbe, Adjumani, Terego, Madi-Okollo and Kiryandongo)

The contractor shall perform the following key tasks in order to meet the objectives of the assignment, including but not limited to:

- **Task 1:** Conduct extensive literature review relevant to the scope of the assignment e.g. previous labour market studies as well as understanding Pillar 1 of the approved Enabel Uganda Country Portfolio 2023-2028 to be able to identify the relevant stakeholders to involve in the study such as private sector companies and businesses, farmer groups, cooperatives, traders and agro processing companies as well as relevant local government departmental heads (Education, Community Development, Production, Labour, Commerce etc.).
- **Task 2:** Conduct extensive secondary data and primary data gathering and analysis to identify the required employable skills and related gaps/upskilling needs within the different occupations/trades/courses in agriculture and the green economy sectors categorized into skills types and levels and with special attention to gender.
- **Task 3:** Identify challenges, aspirations, specific skill gaps and upskilling needs of TVET graduates, inclusive of refugees i.e. settlements and host community, People with disability, teenage parents especially young women, in recognition of prior learning and accessing self and wage employment opportunities in agriculture and the green economy sectors and provide recommendations on the additional skills to be acquired (soft, technical green, digital, entrepreneurship etc.) based on the market need for that specific trade.
- **Task 4:** Visit and hold consultations with relevant employers/private sector actors to find out the current employable skills needs/gaps in the labour market within the different occupations/trades/courses in agriculture and the green economy sectors. Map the private sector actors that are certified to train youth or interested in hosting TVET graduates for upskilling opportunities.
- **Task 5:** Generate the specific types of jobs/employment/entrepreneurship opportunities available and on demand by private sector actors that can be filled by TVET graduates and refugees (settlement and host community) in agriculture and the green economy sectors, including level of skills required and location. Include estimated figures such as number of jobs are available and/or can be created within a certain sector in a certain location.
- **Task 6:** Advise on emerging growth sectors/subsectors that are on demand in the labour market and not covered under agriculture and the green economy sectors, including trades available jobs/employment/entrepreneurship opportunities, and skills levels

required. Include estimated figures such as number of jobs available and/or can be created within a certain sector in a certain location.

# 1.1.1.4 Methodology

For each lot, the contractor is expected to come up with the most suitable methodology towards achieving the set objectives and deliverables. However, it will be important to consider the following:

- Desk review of secondary data including but not limited to; WeWork project documents, TVET policy (2019) document & guidelines, and other TVET, Work Based Learning and Employment Promotion Documents at MoES and MoGLSD, existing previous labour market scan reports, formulation reports, associated partner reports, etc.
- Design and development of data collection tools and instruments. These instruments should be reviewed and validated by Enabel before rollout to ensure that all information of interest is captured. The design of the instruments shall also allow for data disaggregation (e.g., by age, gender).
- Mapping of relevant labour market actors and skills needs for formal and non-formal training.
- Pilot testing of developed data collection instruments and adapted as needed to ensure adequate length, clarity of questions, etc.
- Primary data collection including but not limited to interviews, questionnaires, focused group discussions, workshops, consultations with relevant stakeholders such as vocational training institutions/training providers, private sector actors, line government ministries and relevant district departmental heads, ex-graduates, Enabel project staff, other development actors in Skilling and Employment areas etc.
- Field data collection covering both qualitative and quantitative data from key respondents.
- Data analysis of collected data including but not limited to collating, analysis and interpretation shall be done. The contractor is expected to propose in detail the qualitative and quantitative data analysis approaches that meet the study objectives.
- Any other methods deemed necessary.

# 1.1.1.5 Deliverables

For each of the lots, the following deliverables are expected:

- i. Inception report with a detailed methodology that includes the detailed contractor's activities, work plan, main research methods, sampling framework, sources of data, proposed data collection tools per respondent type, procedure of data collection and analysis, detailed assignment execution programme, etc.
- ii. Approved data collection tools and instruments. These instruments shall be reviewed and validated by Enabel before rollout to ensure that all information of interest is captured.
- A revised final draft report that incorporates information on the skills gap/needs, number of jobs available/can be created as mentioned under both Task 5 and Task 6. This shall be compiled after an extensive review and validation of the first draft by the Enabel technical review team.
- iv. Final presentation and fact sheets to key stakeholders for validation of the key report findings and make adjustments where needed, while supporting dissemination and buyin.

# 1.1.2 Quality management

Quality management is streamlined through the different aspects of the methodology. Detailed Terms of Reference (ToRs) were developed to guide the inception report that shall be agreed upon by the contracting authority.

The Contractor shall ensure quality management through continuous monitoring. This monitoring shall take a quality assurance (QA) approach and collect information on the service provider's conduct in implementing the activities. The different technical aspects of the assignments shall be checked by the respective Enabel technical teams such as Skilling, Employment, Entrepreneurship and Resilience officers etc. as well as public organs at the line ministries and checked by the relevant private institutions in skilling and employment sectors. Besides being consulted for their technical inputs and quality assurance, the Enabel sector experts shall provide approvals of draft assignment deliverables before any part payment or payment in installations of the respective deliverables and most especially vetting the quality of the end of assignment report before final payments.

This QA approach shall be based on the following principles: Collect data systematically; Report these data; Enable timely action on the data, at the appropriate level.

The Contractor shall use these principles to ensure the quality of their service and to monitor the satisfaction of those involved in all aspects of the activities.

# 1.1.3 Project Management

For each of the lots, the contractor shall support Enabel in the process of articulating skills gaps/needs in the priority sectors of agriculture and green economy along the 4 lots.

A debrief meeting shall take place in Kampala between the contactor and the contracting authority representatives i.e. the project management team to discuss the general implementation of the assignment, scope of work and expectations as well as the programme and the communication channels. The meeting shall also aim at clarifying the roles and responsibilities as well as the expected deliverables.

Each Lot shall be headed by the respective project manager, supported by the respective skilling teams for the technical aspects. Thus, the respective project managers shall be the lead managers for this assignment and therefore charged with quality deliverables. They shall be the focal persons for the respective operational and financial perspectives of the assignment.

# **1.2 Requirements for the resources**

#### 1.2.1 Composition of the team

For lot each         • A pool of 3 experts
--

The contractor shall be responsible to present a pool of key experts that can cover all contents of this contract to ensure relevant content and delivery. The coordinator/team leader and key experts are not allowed to offer their services as experts to any other tenderer participating in this tender procedure. This assignment requires 3 experts only per lot **out of which one shall serve as the team leader**. If a tenderer submits for more than one lot, a separate team of experts shall be required for each of the lots tendered

#### **Coordinator/team leader**

The contractor shall be responsible for selecting the key expert out of his pool for delivering the outputs of the specific service requests of the contract. But during the implementation of the contract the contracting authority will individually assess the performance of the key experts and conduct evaluation sessions to get feedback from those participating in the assignment. The

contracting authority reserves the right to reject the key expert if his/her performance is not satisfactory to the contracting authority.

# Individual Experts

The contractor shall be responsible for selecting the individual expert for delivering the outputs of the specific activities of the contract. But each individual expert will require all the following skills and expertise, as specified hereafter.

# 1.2.2 Qualifications of the Team for each of the lots

# Mandatory requirements for the coordinator/ team leader:

- A Master's degree in either Social Sciences, Anthropology, Education Economics, Statistics, Economics, Business Administration, Vocational Studies, etc.
- Good understanding of TVET and capacity building of organizations.
- Good understanding of the business development services and models in both rural and urban setting.
- At least 5 years' experience in research, baseline studies, surveys, needs assessments, capacity building, etc.
- Experience in similar assignments with international development organizations or agencies.

#### Specific competences or knowledge considered an asset:

• Excellent communication, report writing, planning, management and organization skills.

#### Mandatory requirements for the experts

- A Master's degree in either Social Sciences, Anthropology, Economics, Business Administration, Vocational Studies, etc.
- good understanding of TVET and capacity building of organizations.
- good understanding of the business development services and models in both rural and urban setting.
- At least 2 years' experience in research, baseline studies, needs assessments, capacity building, etc.
- Experience in similar assignments with international development organizations.

#### Specific competences or knowledge considered an asset:

- Advanced computer skills including Microsoft Office and web-based applications;
- Excellent communication and facilitation skills;
- Ability to communicate effectively and facilitate discussions at the senior level with government officials;
- Strong and proven research and analytical skills.
- Excellent English language skills (both written and oral).

# 1.2.3 Management of the Team

The contractor shall identify a coordinator / team leader within its organization who shall represent the single point of contact for all administrative and operational communication with the contracting authority. The single point of contact and if necessary, his/her replacement must fulfil the requirements set in the selection criteria. Similarly, the contracting authority shall designate contact persons. Out of these, one will play the Lead consultant / Team Leader role and will be the focal point person, coordinating between the contracting authority (Enabel) and the contractor.

All communications and exchange of information between the contracting authority and the contractor during the contract period shall be held in writing or email, in English and be addressed to the contractor's single point of contact and to the contact person in the contracting authority respectively. The contractor shall ensure that there is a back-up key expert available in the pool. Should a key expert become unavailable for any reason for more than one (1) week, the back-up key expert has to be provided at short notice. The back-up key expert shall continue the implementation at the required standards. Efficient communication and sharing of experience within the contract shall be put in place within the team.

The coordinator shall also supervise the implementation to ensure adaptation of methods and methodology for the assignment. In addition, he/she shall safeguard that the requirements as described in this tender are being kept. The coordinator shall need to closely collaborate with the contracting authority ensuring that the quality of the service meets the standards set.

# **1.2.4 Other Resources**

For each lot, the contractor shall provide arrangements for all logistical needs for the effective execution of the assignment in the different regions. This includes transport, field per diems, suitable venues for meetings, stationery, printing, to mention but a few.

# **1.2.5 Location of activities:**

The assignment shall cover 4 geographical regions i.e.

Lot 1: Albertine/Rwenzori region (Hoima, Kabarole, Kasese and Kyegegwa, City Authorities of Fort Portal, Hoima);

Lot 2: Busoga region (Jinja and Kamuli City Authorities of Fort Portal, Hoima and Jinja);

**Lot 3:** Kampala region (Kampala-KCCA (Kampala Central, Kawempe, Makindye, Nakawa and Rubaga divisions), Mukono and Wakiso);

**Lot 4:** West Nile region (Arua, Yumbe, Adjumani, Terego, Madi-Okollo and Kiryandongo as well as Arua City Authority).

# 2 General provisions

# 2.1 Derogations from the General Implementing Rules

Chapter 'Specific contractual and administrative conditions' of these Tender Specifications (CSC/Cahier Spécial des Charges) holds the specific administrative and contractual provisions that apply to this public procurement contract as a derogation of the Royal Decree of 14.01.2013 or as a complement or an elaboration thereof.

# 2.2 Contracting authority

The contracting authority of this public procurement contract is Enabel, the Belgian development agency, public-law company with social purposes, with its registered office at Rue Haute 147, 1000 Brussels in Belgium (enterprise number 0264.814.354, RPM/RPR Brussels). Enabel has the exclusive competence for the execution, in Belgium and abroad, of public service tasks of direct bilateral cooperation with the partner countries. Moreover, it may also perform other development cooperation tasks at the request of public interest organisations, and it can develop its own activities to contribute towards realisation of its objectives.

For this procurement contract, Enabel is represented by person(s) who shall sign the award letter and are mandated to represent the organisation towards third parties.

# 2.3 Institutional setting of Enabel

The general framework of reference in which Enabel operates is:

- The Belgian Law on Development Cooperation of 19 March 2013<sup>2</sup>;
- The Belgian Law of 21 December 1998 establishing the Belgian Technical Cooperation as a public-law company2;
- The Belgian Law of 23 November 2017 changing the name of the Belgian Technical Cooperation and defining the missions and functioning of Enabel, the Belgian development agency, published in the Belgian Official Gazette on 11 December 2017.

The following initiatives are also guiding Enabel in its operations: We mention as main examples:

- In the field of international cooperation: the United Nations Sustainable Development Goals and the Paris Declaration on the harmonisation and alignment of aid;
- In the field of the fight against corruption: the Law of 8 May 2007 approving the United Nations Convention against Corruption, adopted in New York on 31 October 2003<sup>3</sup>, as well as the Law of 10 February 1999 on the Suppression of Corruption transposing the Convention on Combating Bribery of Foreign Public Officials in International Business Transactions;

# **2.5 Definitions**

The following definitions apply to this procurement contract:

The tenderer: An economic operator submitting a tender;

<u>The contractor/ service provider</u>: The tenderer to whom the procurement contract is awarded;

<u>The contracting authority</u>: Enabel, represented by the Resident Representative of Enabel in Uganda.

<u>The tender</u>: Commitment of the tenderer to perform the procurement contract under the conditions that he has submitted;

<u>Days</u>: In the absence of any indication in this regard in the Tender Specifications and the applicable regulations, all days should be interpreted as calendar days;

<u>Procurement documents</u>: Tender Specifications including the annexes and the documents they refer to;

<u>Technical specifications</u>: A specification in a document defining the characteristics of a product or a service, such as the quality levels, the environmental and climate performance levels, the design for all needs, including accessibility for people with disabilities, and the evaluation of conformity, of product performance, of the use of the product, safety or dimensions, as well as requirements applicable to the product as regards the name by which it is sold, terminology, symbols, testing and test methods, packaging, marking or labelling, instructions for use, the production processes and methods at every stage in the life cycle of the supply or service, as well as the evaluation and conformity procedures;

<u>Variant</u>: An alternative method for the design or the performance that is introduced either at the demand of the contracting authority, or at the initiative of the tenderer;

<u>Option</u>: A minor and not strictly necessary element for the performance of the procurement contract, which is introduced either at the demand of the contracting authority, or at the initiative of the tenderer;

<u>Inventory</u>: The procurement document which splits up the performance in different items and specifies the quantity or the method to determine the price for each of them;

<u>General Implementing Rules (GIR)</u>: Rules laid down in the Royal Decree of 14.01.2013 establishing the General Implementing Rules for public procurement contracts and for concessions for public works;

<u>The Tender Specifications</u> (Cahier spécial des charges/CSC): This document and its annexes and the documents it refers to;

<u>Corrupt practices</u>: The offer of a bribe, gift, gratuity or commission to any person as an inducement or reward for performing or refraining from any act relating to the award of a procurement contract or performance of a procurement contract already concluded with the contracting authority;

Litigation: Court action.

<u>Subcontractor in the meaning of public procurement regulations</u>: The economic operator proposed by a tenderer or contractor to perform part of the contract. The subcontractor is understood as the economic operator with the capacity which the applicant or tenderer relies upon or to whom he entrusts all or part of his engagements.

<u>Controller in the meaning of the GDPR</u>: the natural or legal person, public authority, agency or other body which, alone or jointly with others, determines the purposes and means of the processing of personal data.

<u>Sub-contractor or processor in the meaning of the GDPR:</u> a natural or legal person, public authority, agency or other body which processes personal data on behalf of the controller.

<u>Recipient in the meaning of the GDPR:</u> a natural or legal person, public authority, agency or another body, to which the personal data are disclosed, whether a third party or not.

<u>Personal data:</u> any information relating to an identified or identifiable natural person ('data subject'); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

# 2.6 Processing of personal data by the contracting authority and confidentiality

# 2.6.1 Processing of personal data by the contracting authority

The contracting authority undertakes to process the personal data that are communicated to it in response to the Call for Tenders with the greatest care, in accordance with legislation on the protection of personal data (General Data Protection Regulation, GDPR). Where the Belgian law of 30 July 2018 on the protection of natural persons with regard to the processing of personal data contains stricter provisions, the contracting authority will act in accordance with said law.

# 2.6.2 Confidentiality

The tenderer or contractor and Enabel are bound to secrecy vis-à-vis third parties with regards to any confidential information obtained within the framework of this public contract and will only divulge such information to third parties after receiving the prior written consent of the other party. They will disclose this confidential information only among appointed parties involved in the assignment. They guarantee that said appointed parties will be adequately informed of their obligations in respect of the confidential nature of the information and that they shall comply therewith.

# 2.7 Deontological obligations

Any failure to comply with one or more of the deontological clauses may lead to the exclusion of the candidate, tenderer or contractor from other public procurement contracts for Enabel.

For the duration of the procurement contract, the contractor and his staff respect human rights and undertake not to go against political, cultural or religious customs of the beneficiary country. The tenderer or contractor is bound to respect fundamental labour standards, which are internationally agreed upon by the International Labour Organisation (ILO), namely the conventions on union freedom and collective bargaining, on the elimination of forced and obligatory labour, on the elimination of employment and professional discrimination and on the abolition of child labour.

In accordance with Enabel's Policy regarding sexual exploitation and abuse, the contractor and his staff have the duty to behave in an irreproachable manner towards the beneficiaries of the projects and towards the local population in general. They must abstain from any acts that could be considered a form of sexual exploitation or abuse and they must abide by the basic principles and guidelines laid down in this policy.

Any attempt of a candidate or a tenderer to obtain confidential information, to proceed to illicit arrangements with competitors or to influence the evaluation committee or the contracting authority during the investigation, clarification, evaluation and comparison of tenders and candidates procedure will lead to the rejection of the application or the tender.

Moreover, in order to avoid any impression of risk of partiality or connivance in the follow-up and control of the performance of the procurement contract, it is strictly forbidden to the contractor to offer, directly or indirectly, gifts, meals or any other material or immaterial advantage, of whatever value, to agents of the contracting authority who are concerned, directly or indirectly, by the follow-up and/or control of the performance of the procurement contract, regardless of their hierarchical rank.

The contractor of the procurement contract commits to supply, upon the demand of the contracting authority, any supporting documents related to the performance conditions of the contract. The contracting authority will be allowed to proceed to any control, on paperwork or on site, which it considers necessary to collect evidence to support the presumption of unusual commercial expenditure. Depending on the gravity of the facts observed, the contractor having paid unusual commercial expenditure is liable to have its contract cancelled or to be permanently excluded from receiving funds.

In accordance with Enabel's Policy regarding sexual exploitation and abuse of June 2019 and Enabel's Policy regarding fraud and corruption risk management complaints relating to issues of integrity (fraud, corruption, etc.) must be sent to the Integrity desk through the <a href="https://www.enabelintegrity.be">https://www.enabelintegrity.be</a> website.

# 2.8 Applicable law and competent courts

The procurement contract must be performed and interpreted according to Belgian law.

The parties commit to sincerely perform their engagements to ensure the good performance of this procurement contract.

In case of litigation or divergence of opinion between the contracting authority and the contractor, the parties will consult each other to find a solution.

If agreement is lacking, the Brussels courts are the only courts competent to resolve the matter.

# **3** Modalities of the contract

# **3.1 Type of contract**

This procurement contract is a direct services contract.

# 3.2 Scope of the contract

#### 3.2.1 Subject-matter

This services procurement contract consists in the performance of provision of Consultancy Services to conduct a Labour Market Scan and Analysis for the regions of Albertine/Rwenzori, Busoga, Kampala and West Nile, in conformity with the conditions of these Tender Specifications.

#### 3.2.2 Lots

The procurement contract has 4 lots, each of which is indivisible. The tenderer may submit a tender for one lot, several or all lots. A tender for part of a lot is inadmissible.

The description of each lot is included in Part 1 of these Tender Specifications.

The lots are:

Lot 4	Provision of Consultancy Services to conduct a Labour Market Scan and Analysis in West Nile region (Arua, Yumbe, Adjumani, Terego, Madi-Okollo and Kiryandongo)

#### 3.2.3 Items

For each lot, the contract consists of the items stated in section 1 "Technical specifications" of this tender document.

These items are pooled and form one single procurement contract. It is not possible to tender for one or several items and the tenderer must submit price quotations for all items of the procurement contract.

# **3.3 Duration of the contract**

For each of the lots, the procurement contract starts the day following the date of inception meeting and lasts 60 calender days.

# 4 Special contractual provisions

This chapter of these Tender Specifications holds the specific provisions that apply to this public procurement contract as a derogation of the 'General Implementing Rules for public procurement contracts and for public works concessions' of the Royal Decree of 14 January 2013, hereinafter referred to as 'GIR', or as a complement or an elaboration thereof. The numbering of the articles below (between brackets) follows the numbering of the GIR articles. Unless indicated, the relevant provisions of the General Implementing Rules (GIR) apply in full.

# 4.1 Managing official (Art. 11)

Once the procurement contract is concluded, the managing official is the main contact point for the service provider. Any correspondence or any questions with regards to the performance of the procurement contract will be addressed to him/her, unless explicitly mentioned otherwise in these Tender Specifications.

The managing official is responsible for the follow-up of the performance of the contract.

The managing official is fully competent for the follow-up of the satisfactory performance of the procurement contract, including issuing service orders, drawing up reports and states of affairs, approving the services, progress reports and reviews. (S)he may order any modifications to the procurement contract with regards to its subject-matter provided that they remain within its scope.

However, the signing of amendments or any other decision or agreement implying derogation from the essential terms and conditions of the procurement contract are not part of the competence of the managing official. For such decisions the contracting authority is represented as stipulated under The contracting authority.

Under no circumstances is the managing official allowed to modify the terms and conditions (e.g. performance deadline) of the contract, even if the financial impact is nil or negative. Any commitment, change or agreement that deviates from the conditions in the Tender Specifications and that has not been notified by the contracting authority, will be considered null and void.

# 4.2 Subcontractors (Art. 12 to 15)

The fact that the contractor entrusts all or part of his commitments to subcontractors does not relieve him of liability to the contracting authority. The latter does not recognise any contractual relation with third parties.

The contractor remains, in any case, solely liable to the contracting authority.

The service provider commits to having the procurement contract performed by the persons indicated in the tender, except for force majeure. The persons mentioned or their replacements are all deemed to effectively be involved in the performance of the procurement contract. Any replacements must be approved by the contracting authority.

When the contractor uses a subcontractor to carry out specific processing activities on behalf of the contracting authority, the same data protection obligations as those of the contractor are imposed on that subcontractor by contract or any other legal act.

In the same way, the contractor will respect and enforce to his subcontractors, the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation, GDPR). The contracting authority may conduct an audit of the processing carried out in order to validate compliance with this legislation.

# 4.3 Confidentiality (art. 18)

The knowledge and information gathered by the tenderer under the framework of this public contract is strictly confidential.

Under no circumstances can the information collected, regardless of its origin and nature, be transferred to third parties in any form.

The tenderer is therefore bound by the duty of discretion.

In accordance with Article 18 of the Royal Decree of 14 January 2013 establishing the general rules for public procurement, the tenderer undertakes to consider and process in a strictly confidential manner any information, all facts, any documents and/or any data, whatever their nature and support, which have been communicated to him, in any form and by any means, or to which he has access, directly or indirectly, in the context or on the occasion of this public contract. Confidential information covers, in particular, the very existence of this public contract, without this list being limited.

Therefore, he undertakes to:

- Respect and enforce the strict confidentiality of these elements and to take all necessary precautions in order to preserve their secrecy (these precautions cannot in any case be inferior to those taken by the tenderer for the protection of his own confidential information);
- Consult, use and/or exploit, directly or indirectly, all of the above elements only to the extent strictly necessary to prepare and, if necessary, to carry out this public contract (particularly in accordance with the privacy legislation with respect to personal data processing);
- Not reproduce, distribute, disclose, transmit or otherwise make available to third parties the above elements, in whole or in part, and in any form, unless having obtained prior and written consent of the contracting authority;

- Return, at the first request of the contracting authority, the above elements;
- In general, not disclose directly or indirectly to third parties, whether for advertising or any other reason, the content of this public contract.

# 4.4 Protection of personal data

#### 4.4.1 Processing of personal data by the contracting authority

The contracting authority undertakes to process the personal data that are communicated to it in response to the Call for Tenders with the greatest care, in accordance with legislation on the protection of personal data (General Data Protection Regulation, GDPR). Where the Belgian law of 30 July 2018 on the protection of natural persons with regard to the processing of personal data contains stricter provisions, the contracting authority will act in accordance with said law.

# 4.4.2 Processing of personal data by a subcontractor

During contract performance, the contractor may process personal data of the contracting authority or in execution of a legal obligation.

For any processing of personal data carried out in connection with this public contract, the contractor is required to comply with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (GDPR) and the Belgian law of 30 July 2018 on the protection of natural persons with regard to the processing of personal data.

By simply participating in the contracting process, the tenderer certifies that he will strictly comply with the obligations of the GDPR for any processing of personal data conducted in connection with that public contract.

Given the public contract, it is to be considered that the contracting authority and the contractor will each be responsible, individually, for the processing.

# 4.5 Intellectual property (Art. 19 to 23)

The contracting authority does not acquire the intellectual property rights created, developed or used during performance of the procurement contract.

Without prejudice to clause 1 and unless otherwise stipulated in the procurement documents, when the subject-matter of the procurement contract consists of the creation, manufacture or the development of designs or of logos, the contracting authority acquires the intellectual property thereof, as well as the right to trademark them, to have them registered and to have them protected.

For domain names created under the procurement contract, the contracting authority also acquires the right to register and protect them, unless otherwise stipulated in the procurement documents.

When the contracting authority does not acquire the intellectual property rights, it obtains a patent licence of the results protected by intellectual property law for the exploitation modes that are mentioned in the procurement documents.

The contracting authority lists the exploitation modes for which it intends to obtain a licence in the procurement documents.

# 4.6 Performance bond (Art. 25 to 33)

For each of the lots, the performance bond is set at 5 % of the total contract value in case the awarded amount exceeds 50,000 Euro, excluding VAT, of the procurement contract. The value thus obtained is rounded up to the nearest 10 euros.

In accordance with the legal and regulatory provisions, the performance bond may be constituted either of cash or of public funds or may take the form of a joint performance bond.

The performance bond may also take the form of a surety bond issued by a credit institution meeting the requirements of the law on the statute and control of credit institutions.

As a derogation from Article 26, the performance bond may be posted through an establishment that has its registered office in one of the countries of destination of the services. The contracting authority maintains the right to accept or refuse the posting of the bond through that institution. The tenderer shall mention the name and address of this institution in the tender.

This derogation is founded on the idea of providing possible local tenderers with an opportunity to submit a tender. This measure is made essential by the specific requirements of the contract.

The contractor must, within 30 calendar days from the day of procurement contract conclusion, furnish proof that he or a third party has posted the bond in one of the ways set out below:

1° in the case of cash, by transfer of the amount to the bpost account number of the Deposit and Consignment Office Fill out the form

After reception and validation of said form, an agent of Belgium's Deposit and Consignment Office

(Caisse des Dépôts et Consignations) will communicate to you the payment instructions (account number + communication) for posting the bond in cash;

- 2° in the case of public funds, by depositing such funds, for the account of the Deposit and Consignment Office, with the State Cashier at the head office of the National Bank in Brussels or at one of its provincial agencies or with a public institution with an equivalent function;
- 3° in the case of a joint surety, by deposit via an institution that lawfully carries out this activity of a deed of joint surety with the Deposit and Consignment Office or with a public institution with an equivalent function;
- 4° in the case of a guaranty, by the deed of undertaking of the credit institution

This proof must be provided as applicable by submission to the contracting authority of:

- 1° the deposit receipt of the Deposit and Consignment Office or of a public institution with an equivalent function; or
- 2° a debit notice issued by the credit institution; or

- 3° the deposit certificate issued by the State Cashier or public institution with an equivalent function; or
- 4° the original copy of the deed of joint surety stamped by the Depot and Consignment Office or by a public institution with an equivalent function; or
- 5° the original copy of the deed of undertaking issued by the credit institution granting a guaranty.

These documents, signed by the depositor, must state why the performance bond was posted and its precise usage, consisting of a concise indication of the subject-matter of the procurement contract and a reference to the procurement documents, as well as the name, first name and full address of the contractor and, where relevant, that of the third party that made the deposit on the contractor's account, bearing the statement 'lender' or 'mandatory', as appropriate.

The period of 30 calendar days specified above is suspended during the period of closure of the contractor's business for paid annual holidays and the days off in lieu stipulated by regulation or by a collective binding labour agreement.

Proof that the required performance bond has been posted must be sent to the address that will be mentioned in the contract conclusion notification.

#### Request by the contractor for the acceptance procedure to be carried out:

- 1° For the provisional acceptance: This is equal to a request to release the first half of the performance bond;
- 2° For the final acceptance: This is equal to a request to release the second half of the performance bond, or, in case no provisional acceptance applied, to release the whole of the performance bond.

# 4.7 Conformity of performance (Art. 34)

The works, supplies and services must comply in all respects with the procurement documents. Even in the absence of technical specifications in the procurement documents, the works, supplies and services must comply in all aspects with good practice.

# 4.8 Changes to the procurement contract (Art. 37 to 38/19)

#### 4.8.1 Replacement of the contractor (Art. 38/3)

Provided that he meets the selection and exclusion criteria set out in this document, a new contractor may replace the contractor with whom the initial procurement contract was agreed in cases other than those provided for in Art. 38/3 of the General Implementing Rules (GIR).

The contractor submits his request as quickly as possible by registered post, stating the reasons for this replacement and providing a detailed inventory of the state of supplies and services already performed, the new contractor's contact details and the documents and certificates which the contracting authority cannot access free of charge.

The replacement will be recorded in an amendment dated and signed by all three parties. The initial contractor remains liable to the contracting authority for the performance of the remainder of the procurement contract.

# 4.8.2 Adjusting the prices (Art. 38/7)

For this procurement contract, price reviews are not permitted.

# 4.8.3 Indemnities following the suspensions ordered by the contracting authority during performance (Art. 38/12)

<u>The contracting authority</u> reserves the right to suspend the performance of the procurement contract for a given period, mainly when it considers that the procurement contract cannot be performed without inconvenience at that time.

The performance period is extended by the period of delay caused by this suspension, provided that the contractual performance period has not expired. If it has expired, the return of fines for late performance will be agreed.

When activities are suspended, based on this clause, the contractor is required to take all necessary precautions, at his expense, to protect the services already performed and the materials from potential damage caused by unfavourable weather conditions, theft or other malicious acts. <u>The contractor</u> has a right to damages for suspensions ordered by the contracting authority when:

- The suspension lasts in total longer than one twentieth of the performance time and at least ten working days or two calendar weeks, depending on whether the performance time is expressed in working days or calendar days;
- The suspension is not due to unfavourable weather conditions;
- The suspension occurred during the contract performance period.

Within thirty days of their occurrence or the date on which the contractor or the contracting authority would normally have become aware of them, the contractor reports the facts or circumstances succinctly to the contracting authority and describes precisely their impact on the progress and cost of the procurement contract.

# 4.8.4 Unforeseen circumstances

As a rule, the contractor is not entitled to any modification of the contractual terms due to circumstances of which the contracting authority was unaware.

A decision of the Belgian State to suspend cooperation with a partner country is deemed to be unforeseeable circumstances within the meaning of this article. Should the Belgian State break off or cease activities which implies therefore the financing of this procurement contract, Enabel will do everything reasonable to agree a maximum compensation figure.

# 4.9 Preliminary technical acceptance (Art. 42)

The contracting authority reserves the right to demand an activity report at any time of the assignment to the service provider (meetings held, persons met, institutions visited, summary of results, problems encountered and unresolved issues, deviations from the planning and deviations from the ToR...).

# 4.10 Performance modalities (Art. 146 et seq.)

#### 4.10.1 Deadlines and terms (Art. 147)

The services must be performed within 60 calender days as from the day after the date on which the service provider received the contract conclusion notification letter. The closure of the service provider's business for annual holidays is not included in this calculation.

# 4.10.2 Place where the services must be performed and formalities (Art. 149)

For each of the lots, the services will be performed at the locations specified in the Tender specifications (part 1).

# 4.11 Inspection of the services (Art. 150)

If during contract performance irregularities are found, the contractor will be notified about this immediately by fax or e-mail, which will be confirmed consequently by registered letter. The contractor is bound to perform the non-complying services again.

The service provider advises the managing official by registered post or e-mail showing the exact date of dispatch, at which date the services can be controlled.

# 4.12 Liability of the service provider (Art. 152-153)

The service provider takes the full responsibility for mistakes and deficiencies in the services provided.

Moreover, the service provider indemnifies the contracting authority against damages for which it is liable towards third parties due to late performance of the services or due to failure of the service provider.

# 4.13 Zero tolerance Sexual exploitation and abuse

In application of Enabel's Policy regarding sexual exploitation and abuse of June 2019 there will be zero tolerance towards any misconduct that could impact the professional credibility of the tenderer.

# 4.14 Means of action of the contracting authority (Art. 44-51 and 154 & 155)

The service provider's default is not solely related to services as such but also to the whole of the service provider's obligations.

In order to avoid any impression of risk of partiality or connivance in the follow-up and control of the performance of the procurement contract, it is strictly forbidden to the service provider to offer, directly or indirectly, gifts, meals or any other material or immaterial advantage, of whatever value, to the employees of the contracting authority who are concerned, directly or indirectly, by the follow-up and/or control of the performance of the procurement contract, regardless of their hierarchical rank.

In case of violation, the contracting authority may impose a lump-sum fine to the service provider for each violation, which can be to up to three times the amount obtained by adding up the (estimated) values of the advantage offered to the employee and of the advantage that Tender Specifications – Procurement reference number

the contractor hoped to obtain by offering the advantage to the employee. The contracting authority will decide independently about the application and the amount of this fine.

This clause is without prejudice to the possible application of other measures as of right provided in the GIR, namely the unilateral termination of the procurement contract and/or the exclusion of procurement contracts of the contracting authority for a determined duration.

# 4.14.1 Failure of performance (Art. 44)

§1 The contractor is considered to be in failure of performance under the procurement contract:

1° when the delivery is not carried out in accordance with the conditions specified in the procurement documents;

2° at any time, when the delivery has not progressed in such a way that it can be fully completed on the due dates;

3° when he does not observe written orders, which are given in due form by the contracting authority.

§2 Any failure to comply with the provisions of the procurement contract, including the nonobservance of orders of the contracting authority, is recorded in a report ('process verbal'), a copy of which will be sent immediately to the contractor by registered mail.

The contractor must repair the defects without any delay. He may assert his right of defence by registered letter addressed to the contracting authority within fifteen days from the date of dispatch of the report (process verbal). Silence on his part after this period shall be deemed as acknowledgement of the reported facts.

Any defects detected that can be attributed to the contractor render him liable to one or more of the measures provided for in Articles 45 to 49, 154 and 155.

# 4.14.2 Fines for delay (Art. 46 and 154)

The fines for delay differ from the penalties referred to in Article 45. They are due, without the need for notice, by the mere lapse of the performance term without the issuing of a report and they are automatically applied for the total number of days of delay.

Without prejudice to the application of fines for delay, the contractor continues to guarantee the contracting authority against any damages for which it may be liable to third parties due to late performance of the procurement contract.

# 4.14.3 Measures as of right (Art. 47 and 155)

§1 When, upon expiry of the term given in Article 44, §2, the contractor has not taken action or has presented means deemed unjustified by the contracting authority, the contracting authority may apply the measures as of right described in paragraph 2.

However, the contracting authority may apply measures as of right without waiting for the expiry of the term given in Article 44, §2, when the contractor has explicitly recognised the defects found. §2 The measures as of right are:

1° Unilateral termination of the procurement contract. In this case the entire performance bond, or if no bond has been posted an equivalent amount, is acquired as of right by the contracting authority as lump sum damages. This measure excludes the application of any fine for delay in performance in respect of the terminated part;

2° Performance under regie of all or part of the non-performed procurement contract;

3° Conclusion of one or more replacement procurement contracts with one or more third parties for all or part of the procurement contract remaining to be performed.

The measures referred to in 1°, 2° and 3° will be taken at the expense and risk of the defaulting contractor. However, any fines or penalties imposed during the performance of a replacement procurement contract will be borne by the new contractor.

# 4.15 End of the procurement contract

# 4.15.1 Acceptance of the services performed (Art. 64-65 and 156)

The managing official will closely follow up the services during performance.

The services will not be accepted until after fulfilling audit verifications, technical acceptance and prescribed tests.

The contracting authority disposes of a verification term of thirty days starting on the final or partial end date of the services, set in conformity with the modalities in the procurement documents, to carry out the acceptance formalities and to notify the result to the service provider. This term commences provided that the contracting authority possesses, at the same time, the list of services delivered or the invoice. Upon expiry of the thirty-day term following the date stipulated for completion of the entirety of the services, depending on the case, an acceptance report or a refusal of acceptance report will be drawn up.

Where the services are completed before or after this date, it is the responsibility of the service provider to notify the managing official by registered letter, and at the same time to ask for the acceptance procedure to be carried out. Within thirty days after the date of receipt of the service provider's request, an acceptance or a refusal of acceptance report will be drawn up, depending on the case.

The acceptance specified above is final.

# 4.15.3 Invoicing and payment of services (Art. 66 to 72 – 160)

Only services that have been performed correctly may be invoiced.

The contracting authority disposes of a verification term of thirty days starting on the end date for the services, set in conformity with the modalities in the procurement documents, to carry out the technical acceptance and provisional acceptance formalities and to notify the result to the service provider.

The amount owed to the service provider must be paid within thirty days with effect from the expiry of the verification term or with effect from the day after the last day of the verification term, if this is less than thirty days. And provided that the contracting authority possesses, at the same time, the duly established invoice and final acceptance reports.

When the procurement documents do not provide for any separate debt claim, the invoice will constitute the debt claim.

The invoice must be in EUROS.

In order for Enabel to obtain the VAT exemption and customs clearance documents as quickly as possible, the original invoice and all ad hoc documents will be transmitted as soon as possible before provisional acceptance.

No advance may be asked by the contractor and the Payments shall be made in instalments (progress payments) for each of the 4 Lots as follows:

The contracting authority will in no case be held liable for any damage caused to persons or property as a direct or indirect consequence of the activities required for the performance of this procurement contract. The contractor indemnifies the contracting authority against any claims for compensation by third parties in this respect.

# 5 Procurement procedure

Considering article 14, §2, 1° of the law of June 17, 2016 relating to public procurement, it would not be appropriate to impose the obligation to use electronic means of communication referred to in article 14, § 7, of the law.

The nature of the public contract in question is such that national or regional economic operators do not have equal access to the requirements linked to the use of the Belgian federal "e-Procurement" platform. The technical characteristics can therefore be discriminatory and can restrict the access of economic operators to the procurement procedure, in particular, in terms of speed and quality of the internet connection, as well as the quality of the electricity transport network.

In addition, the particular forms provided by this platform from the point of view of electronic signature are not yet compatible with the ICT generally used.

# 5.1 Type of procedure

This is a Negotiated Procedure without Prior Publication in application of Article 42 of the Law of 17 June 2016.

# 5.2 Publication

# 5.2.1 Enabel publication

This procurement contract is published on the Enabel website https://www.enabel.be/publicprocurement/. Such publication constitutes an invitation to tender. The tender shall also be published in a local newspaper.

# **5.3 Information**

The awarding of this procurement contract is coordinated by the Contract Service Centre of Enabel in Uganda. Throughout this procedure all contacts between the contracting authority and the (prospective) tenderers about this procurement contract will exclusively pass through this service. (Prospective) tenderers are prohibited to contact the contracting authority in any other way with regards to this contract, unless otherwise stipulated in these Tender Specifications.

Until 10 days, candidate-tenderers may ask questions about these Tender Specifications and the procurement contract. Questions will be in writing to UGA\_CSC\_CONTRACTS@enabel.be with copy to aisha.mirembe@enabel.be with a clear indication in the subject of the e-mail of the procedure reference and the contract title. They will be answered in the order received. The complete overview of questions asked will be available at the address mentioned above as soon as available.

Until the notification of the award decision no information will be given about the evolution of the procedure.

The tenderer is supposed to submit his tender after reading and taking into account any corrections made to the contract notice or the Tender Specifications that are published in the

Belgian Public Tender bulletin or that are sent to him by e-mail. To do so, when the tenderer has downloaded the Tender Specifications, it is strongly advised that he gives his coordinates to the public procurement administrator mentioned above and requests information on any modifications or additional information.

In accordance with Article 81 of the Royal Decree of 18 April 2017, the tenderer is required to report immediately any gap, error or omission in the procurement documents that precludes him from establishing his price or compare tenders, within ten days at the latest before the deadline for receipt of tenders.

# **5.4 Preparation and Submission of Tenders**

#### Preparation of tenders

The tenderer shall prepare separately, the administrative, technical and financial proposals as explained below;

#### **Content of tenders**

The tenderer must use the tender form in annexe. In case he does not use this form, he is fully responsible for the perfect concordance between the documents he has used and the form.

By submitting a tender, the tenderer automatically renounces to his own general or specific sales conditions, even if these are mentioned in any of the annexes to his tender.

The tenderer clearly designates in his tender which information is confidential and/or relates to technical or business secrets and may therefore not be divulged by the contracting authority.

The tender shall contain the following parts:

#### 3. Financial Proposal

#### **Determination of prices**

All prices given in the tender form must obligatorily be quoted in EUROS.

This procurement contract is a price-schedule contract, i.e. a contract in which only the unit prices are lump-sum prices. The price to be paid will be obtained by applying the unit prices mentioned in the inventory to the quantities actually performed.

#### Elements included in the price

The service provider is deemed to have included in his unit and global prices any charges and taxes generally applied to services, with the exception of the value-added tax.

The following are in particular included in the prices:

The administrative management and secretariat;

Travel, transportation and insurance;

Documentation pertaining to the services;

The delivery of documents or of pieces related to the performance;

The packaging;

Training required for operation;

Where applicable, the measures imposed by occupational safety and worker health legislation;

Customs and excise duties for equipment and products used;

#### Validity of tenders

The tenderers are bound by their tender for a period of 90 calendar days from the reception deadline date.

The validity of the tender will be negotiated, if the deadline stated above is overrun.

#### 5.4.2 Submission of tenders

Without prejudice to any variants, the tenderer may only submit one tender only per contract.

The tenderer submits his tender as follows:

The duly completed and signed tender shall be submitted only by e-mail and only as attachments and not via a link to a platform. The files shall be clearly named and structured and submitted in a compressed zip folder. The tenderer is solely responsible for the accessibility and legibility of files. The tenderer shall not submit at the last minute. Untimely submission, incomplete submission or indirect submission of documents that are inaccessible or illegible may lead to the rejection of the tender.

The subject of the e-mail shall clearly mention the procurement reference number and the contract title, as stated on the cover page of the tender specifications, as well as the name of tenderer.

Any request for participation or tender shall be received by the Contracting Authority no later than **30**<sup>th</sup> January, 2024, 2:00PM, Kampala time. Requests for participation or tenders that arrive late will not be accepted<sup>12</sup>.

### 5.4.3 Change or withdrawal of a tender that has already been submitted

When a tenderer wants to change or withdraw a tender already sent or submitted this must be done in accordance with the provisions of Articles 43 and 85 of the Royal Decree of 18 April 2017.

To change or withdraw a tender already sent or submitted, a written statement is required, which will be correctly signed by the tenderer or his representative. The subject-matter and the scope of the changes must be indicated in detail. Any withdrawal must be unconditional.

The withdrawal may also be communicated by electronic means, provided that it is confirmed by registered letter deposited at the post office or against acknowledgement of receipt at the latest the day before the tender acceptance deadline.

The subject-matter and the scope of the changes must be indicated in detail.

The withdrawal must be pure and simple.

# 5.5 Opening and evaluation of Tenders

### 5.5.1 Opening of tenderers

The opening of tenders will take place on the day of the final date for receiving tenders indicated above. Tenders not received before this time will be rejected. The opening will take place behind closed doors.

## 5.5.2 Evaluation of Tenders

5.5.2.1 Selection of tenderers

## **Exclusion grounds**

The mandatory and optional exclusion grounds are given in the Declaration on Honour enclosed to these Tender Specifications.

By submitting this tender, the tenderer certifies that he is not in any of the cases of exclusion listed in the Articles 67 to 70 of the Law of 17 June 2016 and the Articles 61 to 64 of the Royal Decree of 18 April 2017.

The contracting authority will verify the accuracy of this Declaration on honour Based on the supporting documents.

### Selection criteria

Moreover, by means of the documents requested in the Annexes - Administrative Proposal, the tenderer must prove that he is sufficiently capable, from an economic and financial as well as from a technical point of view, to successfully perform this public procurement contract.

A tenderer may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which he has with these entities. In that case, the following rules apply:

• Where an economic operator wants to rely on the capacities of other entities, it shall prove to the contracting authority that it will have at its disposal the resources necessary, for example, by producing a commitment by those entities to that effect.

• The contracting authority shall verify whether the entities on whose capacity the economic operator intends to rely fulfil the relevant selection criteria and whether there are grounds for exclusion.

• Where an economic operator relies on the capacities of other entities with regard to criteria relating to economic and financial standing, the contracting authority may require that the economic operator and those entities be jointly liable for the execution of the contract.

• The contracting authority may require certain essential tasks to be carried out directly by the tenderer himself or, if the tender is submitted by a group of economic operators, by a member of the said group.

Under the same conditions, a group of candidates or tenderers may submit the capacities of the group's participants or of other entities.

### Regularity of tenders

The tenders submitted by the selected tenderers will be evaluated as to formal and material regularity. Irregular tenders will be rejected.

The contracting authority reserves the right to have the irregularities in the tenderers' tender regularised during the negotiations.

### 5.5.2.2 qualitative and financial evaluation of tenders

### Negotiation

The formally and materially regular tenders will be evaluated as to content by an evaluation committee. The contracting authority will restrict the number of tenders to be negotiated by applying the award criteria stated in the procurement documents. This evaluation will be conducted on the basis of the award criteria given in these Tender Specifications and aims to setting a shortlist of tenderers with whom negotiations will be conducted.

Then, the negotiation phase follows. In view of improving the contents of the tenders, the contracting authority may negotiate with tenderers the initial tenders and all subsequent tenders that they have submitted, except final tenders. The minimum requirements and the award criteria are not negotiable. However, the contracting authority may also decide not to negotiate. In this case, the initial tender is the final tender.

When the contracting authority intends to conclude the negotiations, it will so advise the remaining tenderers and will set a common deadline for the submission of any BAFOs. Once negotiations have closed, the BAFO will be compared with the exclusion, selection and award criteria. The tenderer whose BAFO shows the best value for money (obtaining the best score based on the award criteria given below) will be designated the contractor for this procurement contract.

### **Award Criteria**

The contracting authority selects the regular tender that it finds to be most advantageous, taking account of the following criteria:

Only tenders with scores of at least 45 points out of 60 points qualify for the financial evaluation.

• Price: 40 %;

With regards to the 'price' criterion, the following formula will be used:

Points tender A = <u>amount of lowest tender</u> \* 40 amount of tender A

### **Final score**

The scores for the qualitative and financial award criteria will be added up. The procurement contract will be awarded to the tenderer with the highest final score, after the contracting authority has verified the accuracy of the Declaration on honour of this tenderer and provided the control shows that the Declaration on honour corresponds with reality.

## **5.6 Award and Conclusion of Contract**

### 5.6.1 Awarding the contract

The procurement contract will be awarded to the tenderer who has submitted the most economically advantageous tender for the lot.

Notice though that in accordance with Art. 85 of the Law of 17 June 2016, there is no obligation for the contracting authority to award the procurement contract.

The contracting authority may either decide not to award the procurement contract; either redo the procedure, if necessary, through another award procedure.

The contracting authority maintains the right to award only a certain lot or certain lots.

### **5.6.2 Concluding the contract**

In accordance with Art. 88 of the Royal Decree of 18 April 2017, the procurement contract occurs through the notification to the selected tenderer of the approval of his tender.

Notification is via e-mail.

So, the full contract agreement consists of a procurement contract awarded by Enabel to the chosen tenderer in accordance with:

- These Tender Specifications and its annexes;
- The approved BAFO of the contractor and all of its annexes;
- The registered letter of notification of the award decision;
- Any later documents that are accepted and signed by both parties, as appropriate.

In an objective of transparency, Enabel undertakes to publish each year a list of recipients of its contracts. By introducing his tender, the successful tenderer declares that he agrees with the publication of the title of the contract, the nature and object of the contract, its name and location, and the amount of the contract.
