Questions	Answers
Can you confirm the budget listed on page 34. Around 1.35 million EUR on total infrastructure of which 0.8 million EUR is for solar-powered desalination?	the 1.35 million EUR mentioned pertains to infrastructure costs under our bilateral program. The additional 0.8 million EUR allocated for solar-powered desalination falls under the BCR program and is separate from the bilateral program. In total, the combined infrastructure budget is approximately 2.15 million EUR.
This is the total estimated infrastructure spend during the period?	Enabel places a strong emphasis on the long-term viability and sustainability of all water systems. This approach allows flexibility in the selection of sites, business models, and technologies. Solar-powered systems defined in BCR program may be replaced by alternative technologies if feasibility studies or contextual assessments suggest that they would be more relevant or viable for the specific context
Could you clarify if there are additional infrastructure works, or are you expecting the tender cost to be below 500k EUR?	Reply: this tender aims at establishing a framework contract for a period of 4 years, allowing Enabel to call upon the selected consultancy firm(s) for one or more of the tasks described in page 35. Request will be sent through TOR. The selected consultancy will then agree with Enabel on methodology, agenda, and number of man-days to execute the request. Each request cost will be based on agreed man-days needed for the execution and fixed by man-day price submitted by successful bidders. Total tender cost will then depend on number of requested support, estimated between 500 and 750 man-days, without fixed budget. Tasks could be related to the capital investment available for water infrastructures (see type2), but other tasks such as project identification (see type1), quality control missions (see type3), or ad hoc support for various activities (see type4).



Could you provide any indication of the locations for the projects to be funded under this initiative?	depending on tasks and activities, work will be conducted in Maputo cities and/or neighbour provinces
Can you confirm whether the Key Experts (Section 5.1.1) are required to be international experts?	no requirements on origin of experts
Similarly, could you clarify if the Short-Term Experts (Section 5.1.2) need to be international, or would regional experts be acceptable?	no requirements on origin of experts
Can you clarify if this correct or is there additional budget available for capital works? What I am trying to verify is that this if not a framework with 30 or 4à million of capital works.	The 2.15 million is the current available budget for infrastructures only, not considering other implementation activities within the portfolio and BCR projects. Total current budget for water related projects is around 4.2 million euro.
	On top of this, in the coming years, additional budgets should come, either in the form of project formulation and/or in the form of project execution. The consultancy would also be mobilized in those contexts, but no specifics can be mentioned at this stage.
The total water related budget (4.2 million euro) relates to this framework project? I am trying to understand if this sum includes capital works costs, consultancy fees and related activities?	4.2 million is the current total budget for water project in Enabel portfolio, including all operations: infrastructures, consultancies, field activities, capacity building, work with communities, etc. For now, the framework contract consultants would be mobilized within that budget to support implementation of some of its actions.
	This total budget could increase on the future for project formulation budgets or new signed project budgets. Framework contract consultants could also be mobilized for those.
Are there any Exclusivity grounds for sub-contractors that participate in multiple bids?	there is no exclusivity. Sub-contractors and key experts can be part of multiple bids.



Are there any Exclusivity grounds for key experts that are part of multiple bids?	there is no exclusivity. Sub-contractors and key experts can be part of multiple bids.
Are the experts exclusive or can they appear in multiple tenders? We note no statement of exclusivity is included in the Tender.	Indeed, there is no exclusivity required. Sub-contractors and experts can appear in multiple tenders.
No CV model is included in the Tender. Is the World Bank the preferred model?	No mandatory model. EU or World Bank models could be used.
The description on Page 44 of the required short-term experts is in the plural i.e. Water quality experts, Hydrologists. However, as we understand, only one CV must be provided per position in the offer?	This is correct, minimum 1 expert.
What is the optimum in terms CV presentation per expert and how will this impact marking of the CVs?	The tenderer is free to present his own format
Does Belgian VAT apply to services provided by a European consultancy firm that is not based in Belgium?	The Mozambican VAT and Witholding tax is applicable
The award criteria require demonstrating the quality of our firm's expertise (30%) and presenting our methodological approach (30%). However, in the overview of documents to be submitted listed at the end of the tender document, I do not see a form to complete or these sections explicitly mentioned.
