## 1 General remarks

## 1.1 Derogations from the General Implementing Rules

Section 4, 'Specific contractual and administrative conditions' of these Tender Specifications (CSC/Cahier Special des Charges) holds the specific administrative and contractual provisions that apply to this public contract by way of derogation from the Royal Decree of 14 January 2013 or as a complement or an elaboration thereof.

These Tender Specifications do not derogate from Art. 25-33 of the General Implementing Rules – GIR (Royal Decree of 14 January 2013) - see point 4.8 "Performance guarantee".

## 1.2 Contracting authority

The contracting authority of this public contract is Enabel, the Belgian development agency, public-law company with social purposes, with its registered office at Rue Haute 147, 1000 Brussels in Belgium (enterprise number 0264.814.354, RPM/RPR Brussels). Enabel has the exclusive competence for the execution, in Belgium and abroad, of public service tasks of direct bilateral cooperation with partner countries. Moreover, it may also perform other development cooperation tasks at the request of public interest organisations, and it can develop its own activities to contribute towards realisation of its objectives.

This tender is launched in the context of the TREPA project (Transforming Eastern Province for Adaptation to Climate Change) financed by the Green Climate Fund (GCF), and implemented through the IUCN, accredited entity by the Ministry of Environment /Rwanda Forestry Authority, Enabel, World Vision, ICRAF and Cordaid. For this public contract, Enabel is represented by the Enabel Rwanda Country Director, **Ms. Virginie HALLET** who will sign the award letter = 'mandataries' / who are mandated to represent the company towards third parties.

## 1.3 Institutional framework of Enabel

The general framework of reference in which Enabel operates is:

- The Belgian Law on Development Cooperation of 19 March 2013<sup>1</sup>;
- The Belgian Law of 21 December 1998 establishing the Belgian Technical Cooperation as a public-law company<sup>2</sup>;
- The Belgian Law of 23 November 2017 changing the name of the Belgian Technical Cooperation and defining the missions and functioning of Enabel, the Belgian development agency, published in the Belgian Official Gazette on 11 December 2017.

The following initiatives are also guiding Enabel in its operations and are given as main examples:

- In the field of international cooperation: the United Nations Sustainable Development Goals and the Paris Declaration on the harmonisation and alignment of aid;
- In the field of the fight against corruption: the Law of 8 May 2007 approving the United Nations Convention against Corruption, adopted in New York on 31 October 2003<sup>3</sup>, as well as the Law of 10 February 1999 on the Suppression of

Corruption transposing the Convention on Combating Bribery of Foreign Public Officials in International Business Transactions:

- In the field of Human Rights: the United Nations' Universal Declaration of Human Rights (1948) as well as the 8 basic conventions of the International Labour Organization4 on Freedom of Association (C. n°87), on the Right to Organise and Collective Bargaining (C. n°98), on Forced Labour (C. n°29 and 105), on Equal Remuneration and on Discrimination in Respect of Employment (C. n°100 and 111), on Minimum Age for Admission to Employment (C. n°138), on the Prohibition of the Worst Forms of Child Labour (C. n°182);
- In the field of environmental protection: The Climate Change Framework Convention of Paris, of 12 December 2015;
- The first Management Contract contracting Enabel and the Belgian federal State (approved by the Royal Decree of 17 December 2017, Belgian Official Gazette of 22 December 2017) that sets out the rules and the special conditions for the execution of public service tasks by Enabel on behalf of the Belgian State.
- Enabel's Code of Conduct of January 2019, Enabel's Policy regarding sexual exploitation and abuse of June 2019 and Enabel's Policy regarding fraud and corruption risk management of June 2019;

## 1.4 Rules governing the public contract

The following, among other things, apply to this public contract:

- The Law of 17 June 2016 on public procurement5;
- The Law of 17 June 2013 on justifications, notification and legal remedies for public contracts and certain contracts for works, supplies and services6;
- The Royal Decree of 18 April 2017 on the awarding of public contracts in the classic sectors7:
- The Royal Decree of 14 January 2013 establishing the General Implementing Rules for public procurement and for concessions for public works8;
- Circulars of the Prime Minister with regards to public procurement.
- Enabel's Policy regarding sexual exploitation and abuse June 2019;
- Enabel's Policy regarding fraud and corruption risk management June 2019:
- Regulation (EU) 2016/679 of the European Parliament and of the Council of 27
  April 2016 on the protection of natural persons with regard to the processing of
  personal data and on the free movement of such data (General Data Protection
  Regulation, hereinafter referred to as 'the GDPR'), and repealing Directive
  95/46/EC;
- Law of 30 July 2018 on the protection of natural persons with regard to the processing of personal data.

#### 1.5 Definitions

The following definitions apply to this contract:

The tenderer: An economic operator submitting a tender;

The contractor/ supplier: The tenderer to whom the public contract is awarded;

The contracting authority: Enabel;

<u>The tender</u>: The commitment of the tenderer to perform the public contract under the conditions that he has submitted;

<u>Days</u>: In the absence of any indication in this regard in the Tender Specifications and the applicable regulations, all days should be interpreted as calendar days;

<u>Procurement documents</u>: Tender Specifications including the annexes and the documents they refer to;

<u>Technical specifications</u>: A specification in a document defining the characteristics of a product or a service, such as the quality levels, the environmental and climate performance levels, the design for all needs, including accessibility for people with disabilities, and the evaluation of conformity, of product performance, of the use of the product, safety or dimensions, as well as requirements applicable to the product as regards the name by which it is sold, terminology, symbols, testing and test methods, packaging, marking or labelling, instructions for use, the production processes and methods at every stage in the life cycle of the supply or service, as well as the evaluation and conformity procedures;

<u>Variant</u>: An alternative method for the design or the performance that is introduced either at the demand of the contracting authority, or at the initiative of the tenderer;

<u>Option</u>: A minor and not strictly necessary element for the performance of the contract, which is introduced either at the demand of the contracting authority, or at the initiative of the tenderer;

<u>Inventory</u>: The procurement document, in a public supply or service contract, which splits up the performance in different items and specifies the quantity or the method to determine the price for each of them;

General Implementing Rules (GIR): Rules laid down in the Royal Decree of 14 January 2013, establishing the General Implementing Rules for public procurement and for concessions for public works;

<u>The Tender Specifications</u> (Cahier spécial des charges/CSC): This document and its annexes and the documents it refers to;

**BDA**: Belgian Public Tender bulletin;

OJEU: Official Journal of the European Union;

OECD: Organisation for Economic Cooperation and Development;

<u>E-tendering</u>: Through the E-tendering platform tenderers can submit and open electronic tenders/requests to participate;

<u>Corrupt practices</u>: The offer of a bribe, gift, gratuity or commission to a person as an inducement or reward for performing or refraining from an act relating to the award of a contract or performance of a contract already concluded with the contracting authority;

Litigation: Court action.

<u>Subcontractor</u> in the meaning of public procurement regulations: The economic operator proposed by a tenderer or contractor to perform part of the public contract.

<u>Controller</u> in the meaning of the GDPR: the natural or legal person, public authority, agency or other body which, alone or jointly with others, determines the purposes and means of the processing of personal data.

<u>Processor</u> (subcontractor) in the meaning of the GDPR: a natural or legal person, public authority, agency or other body which processes personal data on behalf of the controller

<u>Recipient</u> in the meaning of the GDPR: a natural or legal person, public authority, agency or another body, to which the personal data are disclosed, whether a third party or not.

<u>Personal data</u>: any information relating to an identified or identifiable natural person ('data subject'); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

## 1.6 Confidentiality

#### 1.6.1 Processing of personal data

The contracting authority undertakes to process the personal data that are communicated to it under the framework of this procedure with the greatest care, in accordance with legislation on the protection of personal data (General Data Protection Regulation, GDPR). Where the Belgian law of 30 July 2018 on the protection of natural persons with regard to the processing of personal data contains stricter provisions, the contracting authority will act in accordance with said law.

#### 1.6.2 Confidentiality

The tenderer or contractor and Enabel are bound to secrecy vis-à-vis third parties with regards to any confidential information obtained within the framework of this public contract and will only divulge such information to third parties after receiving the prior written consent of the other party.

They will disclose this confidential information only among appointed parties involved in the assignment. They guarantee that said appointed parties will be adequately informed of their obligations in respect of the confidential nature of the information and that they shall comply therewith.

## 1.7 Deontological obligations

1.7.1. Any failure to comply with one or more of the deontological clauses may lead to the exclusion of the candidate, tenderer or contractor from other public contracts for Enabel.

1.7.2. For the duration of the contract, the contractor and his staff respect human rights and undertake not to go against political, cultural or religious customs of the beneficiary country. The tenderer or contractor is bound to respect fundamental labour standards, which are internationally agreed upon by the International Labour Organization (ILO), namely the conventions on union freedom and collective bargaining, on the elimination of forced and obligatory labour, on the elimination of employment and professional discrimination and on the abolition of child labour.

1.7.3. In accordance with Enabel's Policy regarding sexual exploitation and abuse, the contractor and his staff have the duty to behave in an irreproachable manner towards the beneficiaries of the projects and towards the local population in general. They must abstain from any acts that could be considered a form of sexual exploitation or abuse and they must abide by the basic principles and guidelines laid down in this policy.

1.7.4. Any attempt of a candidate or a tenderer to obtain confidential information, to proceed to illicit arrangements with competitors or to influence the evaluation committee or the contracting authority during the investigation, clarification, evaluation and comparison of tenders and candidates procedure will lead to the rejection of the application or the tender.

17.5. Moreover, in order to avoid any impression of risk of partiality or connivance in the follow-up and control of the performance of the public contract, it is strictly forbidden to the contractor to offer, directly or indirectly, gifts, meals or any other material or immaterial advantage, of whatever value, to appointees of the contracting authority who are concerned, directly or indirectly, by the follow-up and/or control of the performance of the contract, regardless of their hierarchical rank.

1.7.6. The public contractor commits to supply, upon the demand of the contracting authority, any supporting documents related to the performance conditions of the contract. The contracting authority will be allowed to proceed to any desk review or on-the-spot check which it considers necessary to collect evidence to support the presumption of unusual commercial expenditure. Depending on the gravity of the facts observed, the contractor having paid unusual commercial expenditure is liable to have his contract cancelled or to be permanently excluded.

1.7.7. In accordance with Enabel's Policy regarding sexual exploitation and abuse of June 2019 and Enabel's Policy regarding fraud and corruption risk management complaints relating to issues of integrity (fraud, corruption, etc.) must be sent to the Integrity desk through the <a href="https://www.enabelintegrity.be">https://www.enabelintegrity.be</a> website.

## 1.8 Litigation management and competent courts

The contract must be performed and interpreted according to Belgian law.

The parties commit to sincerely perform their engagements to ensure the good performance of this contract.

In case of litigation or divergence of opinion between the contracting authority and the contractor, the parties will consult each other to find a solution. If agreement is lacking, the Brussels courts are the only courts competent to resolve the matter (see point 4.14 Disputes).

## 2 Subject-matter and scope of the public contract

## 2.1 Type of contract

This public contract is a framework supply contract

## 2.2 Subject-matter of procurement

This framework public supply contract consists in "The SUPPLY OF MOBILE IMPROVED COOKING STOVES (2025-2026 CAMPAIGN) IN THE EASTERN PROVINCE OF RWANDA - RWA19010-10015, in the context of the TREPA project financed by the Green Climate Fund, in conformity with the conditions of these Tender Specifications. CPV code: 37414600-9

#### **2.3** Lots

The public contract has 12 lots (8 subsidized Lots and 4 non-subsidized Lots), each of which is indivisible. A tender for part of a lot is inadmissible.

The description of the lots is included in the technical specification of these Tender Specifications (see chapter 5).

The lots are as followed:

## For the stoves to be subsidised by TREPA project (lot 1 to 8)

- For the Technology 1: lot 1, lot 2, lot 3, lot 4, lot 5 and lot 6, they have the same requirement:
  - For each of the 6 lots: locally produced mobile cooking stove, with a thermal efficiency superior or equal to 30% (≥30%), accommodating wood and/or crop residues fuel.
  - For each of the 6 lots: estimative quantity of 12.000 stoves to be distributed, with a maximum quantity of 60.000 stoves
  - For each the 6 lots, the stoves have to be subsidized by the TREPA project based on scheme detailed in chapter below. The tenderer has to provide a commitment letter that the stove distributed with this TREPA subsidy support will not be used for any other carbon credit claim. The prices offered by the bidders for the stove should exclude any other carbon credit support.
- **For the Technology 2**: **lot 7 and lot 8**, they have the same requirement:
  - For each of the 2 lots: locally produced mobile high efficient cooking stove efficiency superior or equal to 36% efficiency (≥36%"), accommodating wood and/or crop residues fuel, accompanied with 2 specifically sized pots and adaptor, and 1 heat retaining box
  - For each of the 2 lots: estimative quantity of 8.000 stoves to be distributed, with a maximum of 20.000 stoves
  - For each the 2 lots, the stoves have to be subsidized by the TREPA project based on scheme detailed in chapter below. The tenderer has to provide a commitment letter that the stove distributed with this subsidy support will not be used for any other carbon credit claim. The prices offered by the bidders for the stove should exclude any other carbon credit support.

# > For the stoves already subsidized by another carbon credit system, not to be subsidized by TREPA project (lot 9 to 12)

For the lots n°9 to lot n°12, awarded tenderers will be invited to participate into the demonstration events based at a fixed unit cost per event covered, but the stove disseminated by the tenderers will not be subsidized by the TREPA project. The price offered by tenderers, which is already including the subsidy from other carbon credit scheme, will be fully paid by beneficiaries.

- For the Technology 1: lot 9 and lot 10, they have the same requirement:
  - locally produced mobile cooking stove, with a thermal efficiency superior or equal to 30% (≥30%), accommodating wood and/or crop residues fuel.
  - Affordable price to be fully paid by beneficiaries, not being distributed freely
- For the Technology 2: lot 11 and lot 12, they have the same requirement:
  - For each of the 2 lots: locally produced mobile high efficient cooking stove efficiency superior or equal to 36% efficiency (≥36%), accommodating wood and/or crop residues fuel, accompanied with 2 specifically sized pots and adaptor, and 1 heat retaining box;
  - Affordable price to be fully paid by beneficiaries, not being distributed freely.

The bidder who wants to apply for **TREPA subsidized stove of Technology 1**, has to provide one unique proposal for all the 6 Lots =lot 1, 2, 3, 4, 5 and 6, each of the lots with the same stove and same price.

The bidder who wants to apply for **TREPA subsidized stove of Technology 2**, has to provide one unique proposal for all the two Lots = lot 7 and 8, each of the lots with same stove and same price.

The bidder who wants to apply for **not subsidized stove of Technology 1**, have to provide one unique proposal for both lots 9 and 10, where each of the lots has the same stove and same price.

The bidder who wants to apply for **not subsidized stove of Technology 2**, have to provide one unique proposal for both lots 11 and 12, each of the lots with same stove and same price.

A bidder can apply ONLY for TREPA subsidized stove (lot 1 to 8) or ONLY\_for not subsidized stove (lot 9 to 12), meaning that a same bidder cannot apply for both (subsidized /not subsidized).

A bidder who will submit proposals for subsidized and non-subsidized stoves at the same time will be rejected from the tendering process.

For the TREPA subsidized stove, the same bidder can apply for Technology 1 and for Technology 2, in 2 separate envelopes (one proposal for Technology 1 with the lots 1, 2, 3, 4, 5, 6 and another separate proposal for Technology 2 with the lots 7 and 8).

For the not subsidized stove, a same bidder can also apply for both Technology 1 and for Technology 2, in separate envelopes (one proposal for Technology 1 with the lots 9 and 10) and one separate proposal for Technology 2 with the lots 11 and 12).

If a bidder submits a tender for both technologies, the models (model to be understand in the sense

of **the specific design/prototype**, not in the sense of the brand of the product) of the Improved Cooking Stoves (ICS) proposed for each of the technology **have to be different**.

Also, the same bidder cannot propose 2 models for the same technology. For each targeted technology, the bidder has to propose only one model "its best model".

**For the lot 1 to 6:** among the bidders that will pass the stage of selection, the first 6 having the highest combined score (rank, 1, rank 2, rank 3, rank 4, rank 5 and rank6) will be awarded the tender respectively for lot 1, lot 2, lot 3, lot 4, lot 5 and lot 6. Under Technology 1, one (1) tenderer can be awarded only 1 lot out of the 6 lots.

**For the lot** 7 **and 8**: among the bidders that will pass the stage of selection, the first 2 having the highest combined score (rank, 1, rank 2) will be awarded the tender respectively for lot 7 and 8). Under Technology 2, one (1) tenderer can be awarded only for 1 lot out of the two Lots.

The same applies **for the lot 9 and 10:** whereby among the bidders that will pass the stage of selection, the first 2 tenderers having the highest combined score (rank, 1, rank 2) will be awarded respectively for lot 9 and 10). Under Technology 1, one (1) tenderer can be awarded only for 1 lot.

And **for the lot 11 and 12:** among the bidders that will pass the stage of selection, the first 2 tenderers having the highest combined score (rank, 1, rank 2) will be awarded respectively for lots 11 and 12). Under Technology 2, one (1) tenderer can only be awarded one (1) lot.

Note that one tenderer cannot submit more than 1 proposal in the same technology, this means that any tenderer who submit his proposal as an individual company on one technology is not allowed to also submit a proposal in the same technology as member of a joint venture.

For the non-subsidised Lots (9 to 12), the ranking based on award criteria only aims at selecting the best 4 who will be invited for the demonstration events

When tendering for several lots, the tenderer may not offer discounts or better conditions in his tender in case these lots were to be awarded to him.

#### 2.4 Items

Each of the 12 lots consists of **two (2) items**, as describe below:

#### Item 1: Participation to the ICS demonstration events at community level

The project will organize 1-day demonstration events in each of the 120-140 targeted farmer beneficiary groups, in their community's most appropriate villages.

During these 1-day events, the awarded tenderers (Supplier) will have to ensure the presentation by their professional technicians of their selected ICS model, with practical demonstration.

Every Supplier will be invited to the first 28 demonstration events (first purchase orders).

For the next following events, only the Suppliers that have sold to targeted farmers at least more than 15 stoves per event (being subsidized by the TREPA project or not) in previous 28 demonstration events will be invited and will receive additional purchase order to participate.

The unit cost for participating to the demonstration event is fixed by the Contracting Authority to 100 Euros (VAT excluded) per 1 day event participation (lumpsum cost per 1 day event per service provider per lot, disregarding the number of persons of representatives they want to send in their team).

The following elements will be directly taken in charge (covered) by the project:

- The organization and logistic cost of the demonstration event, except the renumeration (including transport) and mission cost of Supplier's technicians who participate to these events:
- The cost of Enabel ICS animators who will support the ICS dissemination campaign

## Item 2: supply of the selected ICS to the communities

The objective is to supply mobile efficient cooking stoves to the rural households targeted by the TREPA projects in the Eastern Province of Rwanda.

Based on the contributions paid by the registered targeted beneficiaries for their selected ICS model, the concerned Supplier will have to distribute the ICSs to these beneficiaries.

• For lot 1, lot 2, lot 3, lot 4, lot 5, lot 6, lot 9 and lot 10 (Technology 1): supply of mobile improved cooking stove (efficiency (≥30%)

The minimum requirement for this Improved Cooking Stove to be supply are as follows:

- 1. Being a mobile stove sized for a normal household, locally produced (in Rwanda);
- 2. Having an isolating part + an external metallic structure (increasing durability while avoiding hot temperature)
- 3. Accommodating fuel wood as primary fuel
- 4. With a laboratory thermal efficiency superior or equal to 30% to be proven by a testing report from RSB
- 5. Each ICS having a unique serial identifying number or code provided by the suppliers
- For lot 7, lot 8, lot 11 and lot 12 (Technology 2): supply of very highly efficient mobile cooking stove (efficiency ≥36%)) with sized pots and heat retaining box.

The minimum requirement for this Improved Cooking Stove to be supply are as follows:

- 1) Being a mobile stove sized for a normal household, locally produced (in Rwanda);
- Having an isolating part + an external metallic structure (increasing durability while avoiding hot temperature);
- 3) Accommodating fuel wood;
- 4) With a laboratory thermal efficiency superior or equal to 36% (≥36%), to be proven by a testing report from RSB
- 5) Accompany with a heat retaining box and 2 pots of different sizes with adaptors, (optimizing energy transmission to the pot);
- 6) Each ICS having a unique serial identifying number or code provided by the suppliers

Note that at any time during the contract implementation, the Contracting Authority reserves the right of collecting some of the stoves (sample of 6 units per control campaign) distributed to beneficiaries to conduct laboratory testing of the thermal efficiency and verify that the stove is in the required range (+- 10%) of the efficiency provided in the technical offer of the bidder. In case the average efficiency of the sample is lower than the one presented in the proposal (to +/-10%), the Contracting Authority might request the ICS supplier to replace the distributed stoves with the ones having the proposed efficiency, or if this is not possible / complied with, this might lead to termination of the contract.

## 2.5 Duration of the public contract<sup>9</sup>

For each of the lots, the contract starts upon reception of the final notification letter and initially lasts for 12 calendar months (one year).

After this initial term, this contract may be renewed annually by the contracting authority by

registered letter sent within the last month of the contract anniversary date. Depending on the budget and the need/request expressed by beneficiaries, the renewal can only be done once (1).

The renewal will be made as per the terms and conditions of the initial Tender Specifications.

The conditions for renewal are as follows: having successfully distributed at least 1000 stoves in the previous year to the targeted communities, through the organised demonstration events

Should the contract not be renewed, the contractor cannot claim damages.

<u>For information</u> - Pursuant to Article 57 of the Law of 17 June 2016, once a public contract is concluded it may be renewed once or more as per the terms and conditions stated in the initial procurement documents. The total term, including any renewal, may as a general rule not exceed four years from contract conclusion onward. The renewal may not change the global nature of the public contract.

## 2.6 Variants

Each tenderer may submit only one tender per group of Lots (1 bid per Lot 1 to 6 (tech 1), and/or one bid per Lots 7 to 8 (tech 2); OR one per Lot 8 to 9 (tech 1) and/or one per Lot 10 to 11 (tech 2)). Variants are forbidden

## 2.7 Option

Options are not permitted.

## 2.8 Fixed blocks / conditional blocks

For each of the Lot, this public contract will be divided into one or more conditional blocks to be determined by the choice and the needs of the farmers beneficiaries, Although the conclusion of the public contract covers the whole of the contract, note that the execution of each conditional block will be subject to a decision of the contracting authority brought to the attention of the successful tenderers via a freely placed signed Purchase Order by the contracting authority. The estimated maximum quantities are described in the technical specifications.

## 2.9 Quantities

For each of the Lots and items, the estimative quantities are described in the technical specifications.

The presumed quantities are given per lot and per item for information purposes only. The supplier must therefore be able to perform the quantities which will be requested in the order forms, for the whole duration of the public contract. The contracting authority does not commit in any way as to quantities that will be ordered through this contract. The supplier cannot use the fact that the possibly listed quantities were not attained as a basis for claiming compensation.

During the contract period and in function of the evolution of the needs, the contracting authority will be able to commit for additional orders. Such commitment will be made by orders forms. The unit prices quoted in the tender shall be used for the whole duration of the contract.

See Performance modalities: for all or part of the supplies to be provided, the procurement documents provide for one or more partial orders, performance under the contract will be dependent upon notification of each of these orders.

In case of successive orders, the determination of the real quantities will be done through these purchase orders.

## 3 Procedure

## 3.1 Award procedure

This framework contract is awarded in accordance 36 of the Law of 17 June 2016 via an open procedure.

#### 3.2 Publication

#### 3.2.1 Official notification

This contract is officially advertised in the Belgian Public Tender bulletin and in the Official Journal of the European Union.

## 3.2.2 Additional publication

These Tender Specifications are posted on the website of Enabel (<u>www.enabel.be</u>). The contract notice was advertised through the OECD website<sup>10</sup> and in Local newspapers: Job In Rwanda and New Times

#### 3.3 Information

The awarding of this contract is coordinated by Ms. Françoise MUSHIMIYIMANA, National Expert in Contracting and Administration - ECA. Throughout this procedure all contacts between the contracting authority and the (prospective) tenderers about this contract will exclusively pass through this person. (Prospective) tenderers are prohibited to contact the contracting authority in any other way with regards to this contract, unless otherwise stipulated in these Tender Specifications.

Until 28<sup>th</sup> March 2025 (15 days before the submission date) inclusive, candidate-tenderers may ask questions about these Tender Specifications and the public contract. Questions will be in writing to:

#### 3.4 Tender

## 3.4.1 Data to be included in the tender

Tenderers are advised to consult the general principles set out under Heading 1 of the Law of 17 June 2016, which are applicable to this award procedure.

The tenderer must use the tender form in annex. In case he does not use this form, he is fully responsible for the perfect concordance between the documents he has used and the form.

The tender and the annexes to the tender form are drawn up in English.

The tenderer clearly designates in his tender which information is confidential and/or relates to technical or business secrets and may therefore not be divulged by the contracting authority.

#### 3.4.2 Period the tender is valid

The tenderers remain bound by their tender for a period of 120 calendar days from the tender reception deadline date.

#### 3.4.3 Determination of prices

All prices given in the tender form must obligatorily be quoted in euro.

For each of the items, this contract is a price-schedule contract, i.e. a contract in which only the unit prices are lump-sum prices. The price to be paid will be obtained by applying the unit prices given in the inventory to the quantities actually performed / supplied, based on successive purchase orders that will be emitted by the contracting authority and that will fix the maximum of quantities that can be invoiced.

#### 3.4.4 Elements included in the price

## (Art. 32 Royal Decree of 18 April 2017)

The tenderer has to include in his unit and global prices any charges and taxes generally inherent to the performance of the contract, including the value-added tax.

**For item 1**, the lumpsum cost (100 euros/event VAT excluded) will be paid to each bidder participating to demonstration events and is considered as covering all the costs, including the renumeration and mission cost of bidder technicians, bidder promotion material, etc., regardless of the number of technicians representing the bidder.

For item 2, The following are in particular included in the prices to be proposed by the bidder:

8° Acceptance costs (if any)

9° The distribution /installation of the ICS to the beneficiaries at village level

#### The following elements/costs will be taken in charge by the project:

- The organization and logistics cost of the demonstration events.
- The cost of Enabel ICS animators who will support the dissemination campaign

For the item 2 of each lot, the bidders are invited to offer their best unit prices per ICS

However, as per application of the subsidy scheme presented in technical specification (chapter 5), note that only the amount paid as the contribution of the Contracting Authority (subsidy) is considered as the Unit cost to be considered.

The contract will be awarded based on the total unit cost for both items.

#### 3.4.5 How to submit tenders?

(Article 54 et seq. and Art. 83-84 of the Royal Decree of 14 April 2017)

Pursuant to article 14, §2, 1°, 2° and 3° of the law of 17 June 2016 on public contracts, the transmission and reception of bids must be carried out by using transmission by postal service or any other appropriate porterage service.

The bid will be drawn up in **3 copies**, one copy of which will mention "**original**" and the two other copies of which will mention "**copy**". **The identical soft copy MUST also be submitted in one or more PDF files on a USB stick**. Without prejudice to any variants, each Each tenderer may submit only one tender per group of Lots (1 bid per Lot 1 to 6 (tech 1), and/or one bid per Lots 7 to 8 (tech 2); OR one per Lot 8 to 9 (tech 1) and/or one per Lot 10 to 11 (tech 2)).

- a) <u>Either by Post</u> (standard mail or registered mail): In this case, the sealed envelope is put in a second closed envelope. The delivery record makes proof of compliance with the time-limit for receipt.
- b) or <u>hand delivered</u> directly to the contracting authority against a stumped and dated receipt: In this case, the acknowledgment of receipt makes proof of compliance with the time-limit for receipt.

Any bid must arrive before the final submission date and time. Bids that arrive late will not be accepted (Art. 83 of the Royal Decree of 18 April 2017).

The contracting authority draws the attention of tenderers to the fact that sending an offer by email does not meet the conditions of art. 14 § 6 and 7 of the law of June 17, 2016.

The contracting authority reminds that a scanned written signature is not an admissible electronic signature.

## 3.4.6 Change or withdrawal of a tender that has already been submitted

To change or withdraw a tender already sent or submitted a written statement is required, which will be correctly signed by the tenderer or his representative. The subject-matter and the scope of the changes must be indicated in detail. Any withdrawal must be unconditional.

The withdrawal may also be communicated by fax or electronic means, provided that it is confirmed by registered letter deposited at the post office or against acknowledgement of receipt at the latest the day before the tender acceptance deadline.

#### 3.5 Selection of tenderers

Article 66 - 80 of the Law; Articles 59 to 74 of the Royal Decree on Awarding

#### 3.5.1 Exclusion grounds

Articles 52 and 69 of the Law; Article 51 of the Royal Decree of 18.04.2017

The obligatory and facultative grounds for exclusion are given in attachment to these Tender Specifications.

By submitting the Declaration on honour – exclusion criteria enclosed in the annex to these Tender Specifications along with his tender, the tenderer certifies that he is not in any of the cases of exclusion listed in the Articles 67 - 70 of the Law of 17 June 2016 and the Articles 61 - 64 of the Royal Decree of 18 April 2017.

The Bidder will provide with his tender, the required supporting document(s) with regard to the exclusion criteria mentioned under point 6 "Forms" to the contracting authority.

Pursuant to section 70 of the Law of 17 June 2016, any Bidder who is in one of the situations referred to in sections 67 or 69 of the Law of 17 June 2016 may provide evidence to show that the actions taken by him are sufficient to demonstrate his reliability despite the existence of a relevant ground for exclusion. If this evidence is considered sufficient by the contracting authority, the Bidder concerned is not excluded from the award procedure. The contracting authority will verify the accuracy of this Declaration on honour for the tenderer with the best tender. For that purpose, the contracting authority will ask the tenderer concerned to provide information or documents allowing the contracting authority to verify the tenderer's personal situation by the fastest means and within the term set by the contracting authority. The contracting authority may, if possible, itself ask for information or documents that it can obtain free of charge by digital means from the instances that manage the information or documents.

The contracting authority will ask the tenderer, if necessary, at any time during the procedure, to provide all or part of the supporting documents, if necessary to ensure the smooth proceeding of the procedure.

With the exception of the exclusion grounds relating to tax and social security, the tenderer that is in one of the mandatory or optional exclusion situations can prove on his own initiative that he has paid or undertaken to pay compensation for any prejudice caused by the criminal offence or the fault, clarified totally the facts and circumstances by collaborating actively with the authorities in charge of the enquiry and taken concrete specific technical, organisational and personnel measures to prevent a new criminal offence or a new fault.

Conflicts of interest - Revolving doors (Art. 51 Royal Decree 18/04/2017).

Without prejudice to Articles 6 and 69, paragraph 1, 5° of the Law, a conflict of interest is also considered any ('revolving doors') situation in which a natural person who has worked for a contracting authority as an internal staff member, whether in a hierarchy relation or not, as a concerned civil servant, public officer or any other person linked whatsoever to the contracting authority, would later intervene under a public contract awarded by this contracting authority and where a relation exists between the former activities that the above person conducted for the contracting authority and the activities he or she conducts under the contract.

The application of above-mentioned provision is limited however to a two-year term from the resignation of said person or any other type of termination of the former activities.

#### 3.5.2 Selection criteria

Article 71 of the Law and Articles 65 -74 of the Royal Decree of 18 April 2017

Moreover, by means of the documents requested below, the tenderer must prove that he is sufficiently capable, from an economic and financial as well as from a technical point of view, to successfully perform this public contract.

Selection criteria for each of the 12 lots are:

#### - Minimum technical Capacity

- Having at least two (2) years of experience in the field of supply of improved cooking stove either for public or private entities or for individuals, proven by the certificates of good

completion or any document which demonstrate how long the bidder has been in this business.

- Having manufactured and sold/supplied more than 1000 ICS (regardless of the manufactured model) in past 3 years, demonstrated/proven by:
  - Related Certificate(s) of good completion in case it was for supply service contract(s) to public or private entities,
  - And/or the extract of audited accounting showing the number of ICS sold in case of direct selling to individual clients

## - Minimum required financial capacity

The tenderer shall demonstrate its financial capacity, showing that its total turnover for the last 3 years is superior or equal'  $(\ge)$  to the value of the Concerned Lot:

## For lot 1 to lot 8, for TREPA subsidized stoves:

- **For Technology 1** (lot 1 to 6): the estimated total quantity of 12000 stoves (at the unit cost offered by the tenderer); and the estimated total price would be of 12000 X n (n=unit cost of the tenderer).
- **For Technology 2** (lot 7 and 8): the estimated total quantity of 8000 stoves (at the unit cost offered by the tendered); and the estimated total price would be of 8000 X n (n=unit cost of the tenderer)

For Lot 9 to 12 which are not subsidized by TREPA, no minimum financial capacity is required

Only tenders from tenderers (for all the Lots) who meet the selection criteria are taken into consideration in order to participate in the comparison of tenders on the basis of the award criteria set out below, subject to the regularity of these tenders.

## 3.5.3 Modalities relating to tender examination and regularity of the tenders

Art. 75-76 of the Royal Decree of 18 April 2017

For each of the 12 lots, before starting the evaluation and comparison of the tenders, the contracting authority examines their regularity.

The tenders must be drawn up in such a way that the contracting authority can make a selection without starting negotiations with the tenderer. For this reason, and in order to be able to assess the tenders fairly, it is essential that the tenders be completely in conformity with the provisions of the Tender Specifications, both formally and materially.

The substantially irregular tenders are excluded.

A substantial irregularity is such as to give a discriminatory advantage to the tenderer, to distort competition, to prevent the evaluation of the tenderer's tender or its comparison with the other tenders, or to render non-existent, incomplete or uncertain the commitment of the tenderer to perform the contract under the conditions laid down.

The following irregularities are deemed substantial:

- $1^{\circ}$  failure to comply with environmental, social or labour law, provided that such non-compliance is punishable by law;
- 2° failure to comply with the requirements of Articles 38, 42, 43, §1, 44, 48, §2, clause 1, 1alinéa 1er, 54, §2, 55, 83 and 92 of the Royal Decree of 18 April 2017 and of Article 14 of the Law, insofar as they contain obligations vis-à-vis the tenderers;

3° failure to comply with the minimum requirements and the requirements that are indicated as substantial in the procurement documents;

4° tenders that do not bear an original handwritten signature on the tender form.

The contracting authority will also declare void any tender that is affected by several non-substantial irregularities which, by reason of their accumulation or combination, are capable of having the same effect as described above (in accordance with Article 76 of the Royal Decree of 18 April 2017).

#### 3.5.4 Award criteria

Article 81-82 of the Law of 17 June 2016

The 12 lots will be awarded on the basis of best value for money, which is evaluated in the light of the price or cost and criteria related to quality and environmental factors:

- Criterion 1: The quality and technical compliance & respect of environmental factor: thermal efficiency in % (proven by a RSB test reports) with a total score weight of 30%
- Criterion 2: The price with a total score weight of 70% (only for item 2 as the cost of item 1 is fixed in TD)

#### The award criteria are evaluated as follows:

**Award criterion 1** (thermal efficiency) is evaluated on the basis of the RSB ICS test report to be provided by the bidders:

For Technology 1 (lot 1, 2, 3, 4, 5, 6, 9 and 10): the required thermal efficiency required is being superior to 30%. If the thermal efficiency is below 30%, the technical proposal will be considered as not respecting the requirement/ substantial irregularity. A stove with the highest thermal efficiency will get the highest score With regards to the 'thermal efficiency' criterion, the following formula will be used:

Score of Bid A = 30\*A. (Evaluated thermal efficiency)

The highest thermal efficiency

- For Technology 2 (lot 7, 8, 11 and 12), the required thermal efficiency required is being superior to 36%. If the thermal efficiency is below 36%, the technical proposal will be considered as not respecting the requirement/ substantial irregularity.. The same formula as above will be applied.

**Award criterion 2 (price)** is **evaluated on the basis of unit price of item 2** in its financial proposal for the concerned evaluated lot. The lowest price will get the maximum point (70 out of 70). With regards to the 'price' criterion, the following formula will be used:

Score of Bid A = 70\* Unit price of item 2 of lowest bid

Unit price of item 2 of bid A

#### 3.5.4.1 Final score

For each of the lots, the scores for the award criteria will be added up.

The total combined score of each selected bidder will be calculated as follow: Total score = score criterion 1 + score criterion 2

For the lot 1, 2, 3, 4, 5 and 6: among the tenderers that will pass the stage of selection, the first 6 having the highest score (rank, 1, rank 2, rank 3, rank 4, rank 5 and rank

6) will be awarded the tender respectively for lot 1, lot 2, lot 3, lot 4, lot 5 and lot6. Under Technology 1, the same tenderer can be awarded only for one (1) lot.

For the lot 7 and 8: among the tenderers that will pass the stage of selection, the first 2 having the highest score (rank, 1, rank 2) will be awarded respectively for lot 7 and 8). Under Technology 2, the same tenderer can be awarded only for one (1) lot.

For the lot 9 and 10: among the tenderers that will pass the stage of selection, the first 2 having the highest score (rank, 1, rank 2) will be awarded respectively for lot 9 and 10). Under Technology 1, the same tenderer can be awarded only for 1 lot.

For the lot 11 and 12: among the tenderers that will pass the stage of selection, the first 2 having the highest score (rank, 1, rank 2) will be awarded respectively for lot 11 and 12). Under Technology 2, the same tenderer can be awarded only for 1 lot.

As reminder, one bidder can ONLY apply for TREPA subsidized stoves (lot 1 to 8) or ONLY\_for not subsidized stove (lot 9 to 12), meaning that a same bidder cannot apply for both (subsidized /not subsidized).

The contract will be awarded to the tenderers after the contracting authority has verified the accuracy of the Declaration on honour of this tenderer and provided the check shows that the Declaration on honour corresponds with reality.

#### 3.5.4.2 Awarding the public contract

#### Article 36 and 81-82 of the Law of 17 June 2016

For each of the lot, the contract will be awarded to the tenderer according to rules provided above.

Notice though that, in accordance with Art. 85 of the Law of 17 June 2016, there is no obligation for the contracting authority to award the contract.

The contracting authority may either decide not to award the contract, either redo the procedure, if necessary, through another award procedure.

The contracting authority also reserves the right to award only certain lots and to decide that the other lots will be the subject matter of one or more new contracts, if necessary, according to another award procedure in accordance with Article 58 §1, third paragraph.

## 3.5.5 Concluding the public contract

#### Article 88 of the Royal Decree on Awarding

In accordance with Art. 88 of the Royal Decree of 18 April 2017, the contract occurs through the notification to the selected tenderer of the approval of his tender.

Notification is via digital platforms, e-mail or fax and, on the same day, by registered post.

So, the full contract consists of a contract awarded by Enabel to the chosen tenderer in accordance with:

- These Tender Specifications and its annexes;
- The approved tender of the contractor and all of its annexes;
- The registered letter of notification of the award decision;
- Any later documents that are accepted and signed by both parties, as appropriate.

In view of transparency, Enabel undertakes to annually publish the list contractors of its public contracts. By submitting tender, the contractor of the public contract declares agreeing with the publication of the contract title, the nature and subject-matter of the contract, his name and location as well as the value of the contract.

## 4 Special contractual provisions

This chapter of these Tender Specifications holds the specific provisions that apply to this public contract by way of derogation from the 'General Implementing Rules for public procurement and for concessions for public works' of the Royal Decree of 14 January 2013, hereinafter referred to as 'GIR' or as a complement or an elaboration thereof. The numbering of the articles below (between brackets) follows the numbering of the GIR articles. Unless indicated, the relevant provisions of the General Implementing Rules (GIR) apply in full.

These Tender Specifications do not derogate from Article(s) 25-33 of the General Implementing Rules the GIR.

## 4.1 Definitions (Art. 2)

- <u>Contract manager/Managing Official</u>: The official or any other person who manages and controls the performance of the contract;
- <u>Performance guarantee</u>: Financial guarantee given by the successful Bidder to cover its obligations until final and good performance of the contract;
- <u>Acceptance</u>: Observation by the contracting authority that the performance of all or part of the
  works, supplies or services is in compliance with good practice and with the terms and
  conditions of the contract;
- Progress payment: Payment of an instalment under the contract after service delivery is accepted;
- Advance: Payment of part of the contract before service delivery is accepted;
- <u>Amendment</u>: Agreement established between the contracting parties during contract performance in view of changing documents applicable to the contract.

## 4.2 Use of electronic means (art. 10)

The adjudicator "authorizes" the use of electronic means for the exchange of written documents, **except for the bids**. Whether electronic means are used or not, communications, exchanges and storage of information take place in such a way as to ensure that the integrity and confidentiality of the data are preserved.

## 4.3 Managing official (Art. 11)

The managing official is Mr. Jacques PEETERS, Sector and Thematic Expert -TREPA Program, E-mail: jacques.peeters@enabel.be, to be also mentioned in the notification letter

The managing official is responsible for the follow-up of the performance of the contract.

Once the public contract is concluded the managing official is the main contact point for the supplier. Any correspondence or any questions with regards to the performance of the contract will be addressed to him or her, unless explicitly mentioned otherwise in these Tender Specifications.

The managing official is fully competent for the follow-up of the satisfactory performance of the contract, including issuing service orders, drawing up reports and states of affairs, approving the services, progress reports and reviews. He or she may order any modifications to the contract with regards to its subject-matter provided that they remain within its scope.

However, the signing of amendments or any other decision or agreement implying derogation from the essential terms and conditions of the contract are not part of the competence of the managing official. For such decisions the contracting authority is represented as stipulated under 'The contracting authority'.

Under no circumstances is the managing official allowed to modify modalities (e.g. performance period) of the contract, even if the financial impact is nil or negative. Any commitment, change or

agreement derogating the conditions in the Tender Specifications and that has not been notified by the contracting authority, will be considered null and void. For such decisions the contracting authority is represented as stipulated under 'The contracting authority'.

## 4.4 Subcontractors (Art. 12 to 15)

The fact that the successful tenderer (or supplier) entrusts all or part of its commitments to subcontractors does not release its liability towards the contracting authority. The latter does not recognize any contractual link with these third parties.

The successful tenderer remains, in all cases, solely responsible vis-à-vis the contracting authority. The supplier commits to having the contract performed by the persons indicated in the tender, except for force majeure. The persons mentioned or their replacements are all deemed to effectively be involved in the performance of the contract. Any replacements must be approved by the contracting authority.

When the supplier uses a subcontractor to carry out specific processing activities on behalf of the contracting authority, the same data protection obligations as those of the contractor are imposed on that subcontractor by contract or any other legal act.

In the same way, the contractor will respect and enforce to his subcontractors, the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation, GDPR). The contracting authority may conduct an audit of the processing carried out in order to validate compliance with this legislation.

## 4.5 Confidentiality (Art. 18)

Knowledge and information obtained by the contractor, including any persons responsible for the mission and another person involved in this public contact, are strictly confidential.

Under no circumstances can the information collected, regardless of its origin and nature, be transferred to third parties in any form.

All parties directly or indirectly involved are therefore bound by the duty of discretion.

In accordance with Article 18 of the Royal Decree of 14 January 2013 establishing the general rules for public procurement, the tenderer or contractor undertakes to consider and process in a strictly confidential manner any information, all facts, any documents and/or any data, whatever their nature and support, which have been communicated to him, in any form and by any means, or to which he has access, directly or indirectly, in the context or on the occasion of this public contract. Confidential information covers, in particular, the very existence of this public contract, without this list being limited.

Therefore, he undertakes to:

- Respect and enforce the strict confidentiality of these elements and to take all necessary precautions in order to preserve their secrecy (these precautions cannot in any case be inferior to those taken by the tenderer for the protection of his own confidential information);
- Consult, use and/or exploit, directly or indirectly, all of the above elements only to the extent strictly necessary to prepare and, if necessary, to carry out this public contract (particularly in accordance with the privacy legislation with respect to personal data processing);
- Not reproduce, distribute, disclose, transmit or otherwise make available to third parties the above

elements, in whole or in part, and in any form, unless having obtained prior and written consent of the contracting authority;

- Return, at first request of the contracting authority, the above elements;
- In general, not disclose directly or indirectly to third parties, whether for advertising or any other reason, the content of this public contract, or the fact that the tenderer or contractor performs this public contract for the contracting authority, or, where applicable, the results obtained in this context, unless having obtained prior and written consent of the contracting authority. »

## 4.6 Personal data protection

#### 4.4.1 Processing of personal data by the contracting authority

The contracting authority undertakes to process the personal data that are communicated to it in response to the Call for Tenders with the greatest care, in accordance with legislation on the protection of personal data (General Data Protection Regulation, GDPR). Where the Belgian law of 30 July 2018 on the protection of natural persons with regard to the processing of personal data contains stricter provisions, the contracting authority will act in accordance with said law.

#### 4.4.2 Processing of personal data by the contractor

Where during contract performance, the contractor may process personal data of the contracting authority exclusively in the name and on behalf of the contracting authority, for the sole purpose of performing the services in accordance with the provisions of the Tender Specifications or in execution of a legal obligation.

For any processing of personal data carried out in connection with this public contract, the contractor is required to comply with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (GDPR) and the Belgian law of 30 July 2018 on the protection of natural persons with regard to the processing of personal data.

By simply participating in the contracting process, the tenderer certifies that he will strictly comply with the obligations of the GDPR for any processing of personal data conducted in connection with that public contract.

The personal data that will be processed are confidential. The contractor will therefore limit access to data to the strictly necessary personnel for the performance, management and monitoring of the public contract.

For the performance of the public contract, the contracting authority will determine the purposes and means of processing personal data. In this case, the contracting authority will be responsible for the processing and the contractor will be its processor, within the meaning of Article 28 of the GDPR.

Processing carried out on behalf of a controller must be governed by a contract or other legal act that is binding on the processor with regard to the personal data controller and that sets out that the subcontractor acts only on the instruction of the person in charge of the processing and that the confidentiality and security obligations regarding the processing of personal data are also the responsibility of the subcontractor - Article 28 §3 of the GDPR.

To this end, the tenderer must fill out, sign and submit to the contracting authority the subcontracting agreement given in Annex 17.

## 4.7 Intellectual property (Art. 19 to 23)

The contracting authority acquires the intellectual property rights created, developed or used during performance of the public contract.

Without prejudice to clause 1 and unless otherwise stipulated in the procurement documents, when the subject-matter of the public contract consists of the creation, manufacture or the development of designs or of logos, the contracting authority acquires the intellectual property thereof, as well as the right to trademark them, to have them registered and to have them protected.

For domain names created under the contract, the contracting authority also acquires the right to register and protect them, unless otherwise stipulated in the procurement documents.

Where the contracting authority does not acquire the intellectual property rights, it obtains a patent licence of the results protected by intellectual property law for the exploitation modes that are mentioned in the procurement documents.

The contracting authority lists the exploitation modes for which it intends to obtain a licence in the procurement documents.

## 4.8 Performance bond (Art. 25 to 33)

The performance bond is set at 5% of the total value of each specific purchase order, excluding VAT. The value thus obtained is rounded up to the nearest 10 euros.

In accordance with the legal and regulatory provisions, the performance bond may be constituted either of cash or of public funds or may take the form of a joint performance bond.

The performance bond may also take the form of a surety bond issued by a credit institution meeting the requirements of the law on the statute and control of credit institutions (ONLY BANK GUARANTEE),

**By way of derogation from Article 26** the performance bond may be posted through an establishment that has its registered office in one of the countries of destination of the services. The contracting authority reserves the right to accept or refuse the posting of the bond through that institution. The tenderer mentions the name and address of this institution in the tender.

This derogation is founded on the idea of providing possible local tenderers with an opportunity to submit a tender. This measure is made essential by the specific requirements of the contract.

The contractor must, within 30 calendar days from the day of contract conclusion, furnish proof that he or a third party has posted the bond in one of the ways set out below:

- 1° in the case of cash, by transfer of the amount to the bpost bank account number of the Deposit and Consignment Office Complete the following form as well as possible: https://finances.belgium.be/sites/default/files/01\_marche\_public.pdf
  (PDF, 1.34 Mo), and forward it by e-mail to info.cdcdck@minfin.fed.be
- 2° in the case of public funds, by depositing such funds, for the account of the Deposit and Consignment Office, with the State Cashier at the head office of the National Bank in Brussels or at one of its provincial agencies or with a public institution with an equivalent function
- 3° in the case of a joint surety, by deposit via an institution that lawfully carries out this activity of a deed of joint surety with the Deposit and Consignment Office or with a public institution with an equivalent function

4° in the case of a guaranty, by the deed of undertaking of the credit institution.

Such proof is provided, as appropriate, by submission to the contracting authority of:

- 1° the deposit receipt of the Deposit and Consignment Office or of a public institution with an equivalent function; or
- 2° a debit notice issued by the credit institution; or
- 3° the deposit certificate issued by the State Cashier or public institution with an equivalent function; or
- 4° the original copy of the deed of joint surety stamped by the Depot and Consignment Office or by a public institution with an equivalent function; or
- 5° the original copy of the deed of undertaking issued by the credit institution granting a guaranty.

These documents, signed by the depositor, must state why the performance bond was posted and its precise usage, consisting of a concise indication of the subject-matter of the contract and a reference to the procurement documents, as well as the name, first name and full address of the contractor and, where relevant, that of the third party that made the deposit on the contractor's account, bearing the statement "lender" or "mandatary" as appropriate.

The period of 30 calendar days specified above is suspended during the period of closure of the contractor's business for paid annual holidays and the days off in lieu stipulated by regulation or by a collective binding labour agreement.

Proof that the required performance bond has been posted must be sent to the address that will be mentioned in the contract conclusion notification.

## 4.8.1 Failure to post the performance guarantee (Art. 29)

When the supplier fails to prove that the performance guarantee has been posted within 30 calendar days, he will be set in default by letter. This notification will be considered as a 'failure report' as mentioned in art. 44, § 2 of the General Implementing Rules (see below).

When, after notification of this failure by letter, the supplier has still failed to produce proof that the performance guarantee has been posted within a further period of 15 calendar days dating from the date of dispatch of the letter, the contracting authority may:

- 1º Post the performance guarantee itself by deduction from amounts due under the contract in question; in this case, the penalty shall be fixed at a flat rate of 2% of the initial amount of the contract; or
- 2° Apply the measures taken as of right. In any event, termination of the contract for this reason shall preclude the application of penalties or fines for delay.

#### 4.8.2 Release of the Guarantee (Art. 33)

#### Request by the contractor for the acceptance procedure to be carried out:

- 1° For provisional acceptance of supplied items: This is equal to a request to release the first half of the performance bond,
- 2° For final acceptance: This is equal to a request to release the second half of the performance bond, or, in case no provisional acceptance applied, to release the whole of the performance bond.

## 4.9 Conformity of performance (Art. 34)

The works, supplies and services must comply in all respects with the procurement documents. Even in the absence of technical specifications in the procurement documents, the works, supplies and services must comply in all aspects with good practice.

## 4.10 Changes to the public contract (Art. 37 to 38/19)

## 4.10.1 Replacement of the supplier (Art. 38/3)

Provided that he meets the selection and exclusion criteria set out in this document, a new supplier may replace the supplier with whom the initial contract was agreed in cases other than those provided for in Art. 38/3 of the General Implementing Rules (GIR).

The supplier submits his request as quickly as possible by registered post, stating the reasons for this replacement and providing a detailed inventory of the state of the supplies and services already delivered, the new supplier's contact details and the documents and certificates which the contracting authority cannot access free of charge.

The replacement will be recorded in an amendment dated and signed by all three parties. The initial supplier remains liable to the contracting authority for the performance of the remainder of the contract.

#### 4.10.2 Revision of prices (Art. 38/7)

For this contract, price revisions are not permitted.

# 4.10.3 Indemnities following the suspensions ordered by the contracting authority during performance (Art. 38/12)

<u>The contracting authority</u> reserves the right to suspend the performance of the contract for a given period, mainly when it considers that the contract cannot be performed without inconvenience at that time.

The performance period is extended by the period of delay caused by this suspension, provided that the contractual performance period has not expired. If it has expired, the return of fines for late performance will be agreed.

When activities are suspended, based on this clause, the supplier is required to take all necessary precautions, at his expense, to protect the services already performed and the materials from potential damage caused by unfavourable weather conditions, theft or other malicious acts.

**The supplier** has a right to damages for suspensions ordered by the contracting authority when:

- The suspension lasts in total longer than one twentieth of the performance period and at least ten working days or two calendar weeks, depending on whether the performance period is expressed in working days or calendar days;
- The suspension is not owing to unfavourable weather conditions;
- The suspension occurred during the contract performance period.

Within thirty days of their occurrence or the date on which the supplier or the contracting authority would normally have become aware of them, the supplier reports the facts or circumstances succinctly to the contracting authority and describes precisely their impact on the progress and cost of the contract.

## 4.10.4 Unforeseeable circumstances

As a rule, the supplier is not entitled to any modification of the contractual terms due to circumstances of which the contracting authority was unaware.

A decision of the Belgian State to suspend cooperation with a partner country is deemed to be unforeseeable circumstances within the meaning of this article. Should the Belgian State break off or cease activities which implies therefore the financing of this public contract, Enabel will do everything reasonable to agree a maximum compensation figure.

#### 4.10.5 Terms of introduction (Art. 38/14)

The contracting authority or the successful tenderer who wishes to rely on one of the review clauses, as referred to in Articles 38/09 to 38/12, must disclose the facts or circumstances on which it is based, in writing within 30 days. of their occurrence or of the date on which the successful tenderer or the contracting authority should normally have known of them.

## 4.11 Preliminary technical acceptance (Art. 41 -42)

Products may not be used if they have not been accepted by the managing official or his or her representative.

Products that at a given stage do not satisfy the technical acceptance tests imposed will be declared unfit for technical acceptance. Upon the request of the supplier, the contracting authority in accordance with the procurement documents verifies whether the products have the required qualities or at the very least comply with good practice and satisfy the conditions of the contract. If certain products are destroyed during verification, the supplier replaces these at its own expense. The procurement documents specify the quantity of products to be destroyed.

Where the contracting authority declares that the product presented is not in the required condition for examination, the acceptance request by the building supplier will be considered not having been made. A new request is made when the product is fit for acceptance.

## 4.12 Performance modalities (Art. 115 et seq.)

## 4.12.1 Partial orders (Art. 115)

If, for all or part of the quantities to be supplied, the procurement documents provide for one or more partial orders, performance under the contracts will be dependent upon notification of each of these orders.

For each Lot, the contracting authority will draw up a '**purchase order**', which will be notified by letters any time during the contract duration.

The delivery of the quantities demanded through the purchase orders/PO will be performed upon request of the contracting authority. The requests will be made in function of the needs of the contracting authority and final beneficiaries. Each request will indicate **the lot, item, quantities, delivery place**. The Supplier will respond to the purchase order/PO by letter indicating the maximum delivery time and confirming the items to be delivered as well as delivery place.

## 4.12.2 Deadlines and terms (Art. 116)

For each of the purchase order of each of the lots, the supplies must be delivered within a period that is to be expressed in calendar weeks into the detail technical description provided in chapter 5, and the maximum set by the contracting authority is 6 calendar weeks which has to be confirmed by tenderer in his tender. For each purchase order, the period starts as from the day following the date on which the supplier received the letter the purchase order. All days are indistinguishably included in the period,

The Purchase Order is addressed to the supplier either by registered letter, fax or any other means through which the date of dispatch can be determined unambiguously.

When the Purchase Order is clearly incorrect or incomplete and implementation of the order

becomes impossible, the supplier immediately notifies the service that placed the order about this in writing in order to find a solution to allow for normal implementation of the order.

## 4.12.3 Quantities to be supplied (Art. 117)

For each lot, the public framework contract's estimated and maximum quantities are mentioned under 'Quantities'. The real quantities to be supplied will be fixed in the successive purchase order that will be provided to the awarded bidders, based on the choice of the stove that will be made during the demonstration events by the targeted beneficiaries registered in the lists.

Without prejudice to the possibility for the contracting authority to terminate the contract if the supplies delivered do not meet the requirements imposed or if they are not delivered by the deadlines asked, by concluding this contract the supplier acquires the right to deliver these quantities, under penalty of indemnification by the contracting authority.

#### 4.12.4 Place where the services must be performed and formalities (Art. 149)

The supplies will be delivered in the targeted villages communities across the 7 Districts of the Eastern Province. See chapter 5for more details. The villages concerned will be given in annexed list of beneficiaries for each purchase order.

## 4.12.5 Packaging (Art. 119)

Packaging will become the property of the contracting authority, without the supplier having any claim to compensation in this regard.

#### 4.12.6 Inspection of the supplies delivered (Art. 120)

The supplier delivers only goods that have no apparent and/or hidden defects and that correspond strictly to the order (in kind, quantity, quality...) and, if necessary, to the prescriptions of related documents as well as applicable regulations, in compliance with good practice, the state of the art, the highest standards of usage, of reliability and of longevity, and for the purposes that the contracting authority has in mind, which the supplier knows or at least should know.

Acceptance (provisional acceptance) only takes place after the complete inspection by the contracting authority of the conformity of the goods and services delivered. The contracting authority disposes of a period for verification of thirty days starting on the date of delivery. This period will begin on the day after arrival of the supplies at the place of delivery, provided that the contracting authority is in possession of the delivery note or invoice.

The signature of (a staff member of) the contracting authority, in particular in electronic reception devices, upon delivery of the goods, does consequently only count as evidence of taking possession and does not concern the acceptance of the goods.

Acceptance on site counts as complete provisional acceptance

Acceptance implies the transfer of ownership and of risks of damage and loss.

In case of full or partial refusal of a delivery, the supplier is bound to take back, at his own costs and risks, the products refused. The contracting authority may ask the supplier to deliver goods that comply as soon as possible, either cancel the order and get supplied by another supplier.

Note that at any time during the contract implementation, the Contracting Authority reserve the right of collecting some of the stoves (sample of 6 units per control campaign) distributed to beneficiaries to conduct laboratory testing of the thermal efficiency and verify that the stove is in the range (+- 10%) of the efficiency provided in the technical offer of the bidder. In case the average efficiency of the sample is lower than the one presented in the proposal (+/-10%), the Contracting Authority might request the ICS

supplier to replace the distributed stove with the one having the right announced efficiency, or if this is not possible, to terminate the contract.

## 4.12.7 Gender equality

In accordance with article 3, 3 ° of the law of January 12, 2007 "Gender Mainstreaming", public contracts must take into account any differences between women and men (the gender dimension). The successful tenderer must therefore analyse, depending on the area concerned by the contract, whether there are any differences between women and men. As part of the performance of the contract, it must therefore take into account the differences noted. Communication should fight against sexist stereotypes in terms of message, image and language, and take into account the differences in the situation between women and men in the target audience.

#### 4.12.8 Zero tolerance Sexual exploitation and abuse

In application of Enabel's Policy regarding sexual exploitation and abuse of June 2019 there will be zero tolerance towards any misconduct that could impact the professional credibility of the tenderer.

## 4.13 Liability of the supplier (Art. 122)

The supplier shall be liable for his supplies up to the time when the inspection and notification formalities referred to under Article 120 are carried out, unless losses or damage sustained in the warehouses of the consignee are due to the events or circumstances referred to in Articles 54 and 56.

Moreover, the supplier indemnifies the contracting authority against damages for which it is liable towards third parties due to late performance of the contract or due to failure of the supplier

## 4.14 Means of action of the contracting authority (Art. 44-51 and 123-126)

The supplier 's default is not solely related to performance as such but also to the whole of the supplier 's obligations.

In order to avoid any impression of risk of partiality or connivance in the follow-up and control of the performance of the public contract, it is strictly forbidden to the supplier to offer, directly or indirectly, gifts, meals or any other material or immaterial advantage, of whatever value, to appointees of the contracting authority who are concerned, directly or indirectly, by the follow-up and/or control of the performance of the contract, regardless of their hierarchical rank.

In case of violation, the contracting authority may impose a lump-sum fine to the supplier for each violation, which can be to up to three times the amount obtained by adding up the (estimated) values of the advantage offered to the employee and of the advantage that the supplier hoped to obtain by offering the advantage to the employee. The contracting authority will decide independently about the application and the amount of this fine.

This clause is without prejudice to the possible application of other measures as of right provided in the GIR, namely the unilateral termination of the contract and/or the exclusion from procurement by the contracting authority for a determined duration.

#### 4.14.1 Failure of performance (Art. 44)

§1 The supplier is considered to be in failure of performance under the public contract:

- 1° when the delivery is not carried out in accordance with the conditions specified in the procurement documents;
- 2° at any time, when the delivery has not progressed in such a way that it can be fully completed on the due dates;
- 3° when he does not observe written orders, which have been given in due form by the contracting

authority.

§2 Any failure to comply with the provisions of the public contract, including the non-observance of orders of the contracting authority, is recorded in a report ('process verbal'), a copy of which will be sent immediately to the supplier by registered mail.

The supplier must repair the defects without any delay. He may assert his right of defence by registered letter addressed to the contracting authority within fifteen days from the date of dispatch of the report (process verbal). Silence on his part after this period shall be deemed acknowledgement of the reported facts.

Any defects detected that can be attributed to the supplier render him liable to one or more of the measures provided for in Articles 45 to 49, 154 and 155.

#### 4.14.2 Fines for delay (Art. 46 and 123)

The fines for delay differ from the penalties referred to in Article 45. They are due, without the need for notice, by the mere lapse of the performance period without the issuing of a report and they are automatically applied for the total number of days of delay.

Regardless of the application of any fines for delay, the supplier indemnifies the contracting authority against damages for which it is liable towards third parties due to late performance of the contract.

## 4.14.3 Measures as of right (Art. 47 and 124)

§1 When, upon expiry of the term given in Article 44, §2, the supplier has not taken action or has presented means deemed unjustified by the contracting authority, the contracting authority may apply the measures as of right described in paragraph 2.

However, the contracting authority may apply measures as of right without waiting for the expiry of the term given in Article 44, §2, when the supplier has explicitly recognised the defects detected.

§2 The measures as of right are:

- 1° Unilateral termination of the contract. In this case the entire performance bond, or if no bond has been posted an equivalent amount, is acquired as of right by the contracting authority as lump sum damages. This measure excludes the application of any fine for delay in performance in respect of the terminated part;
- 2° Performance under regie of all or part of the non-performed contract;
- 3° Conclusion of one or more replacement contracts with one or more third parties for all or part of the contract remaining to be performed.

The measures referred to in 1°, 2° and 3° will be taken at the expense and risk of the defaulting supplier. However, any fines or penalties imposed during the performance of a replacement contract will be borne by the new supplier.

## 4.15 End of the public contract

## 4.15.1 Acceptance of the products delivered (Art. 64-65 and 120)

The contracting authority disposes of a period for verification of thirty days starting on the end date of the delivery, set in conformity with the modalities in the procurement documents, to carry out the technical acceptance and provisional acceptance formalities and to notify the result to the supplier.

When the supplies will be delivered before or after this date, it is the responsibility of the supplier to inform them by registered mail or electronic mail, ensuring in an equivalent manner the date of dispatch to the managing official and to ask, at the same time, to proceed to reception. Within thirty days of the date of receipt of the suppliers request, a report of receipt or refusal of receipt is drawn up, as the case

may be.

The products are stored for delivery in the supplier's warehouses. Delivery cannot occur prior to the contracting authority's accepting the goods stored for delivery. The managing official who will carry out acceptance is named in the contract award notification if his/her name has not yet been mentioned in the procurement documents.

In this contract, the following acceptances are provided for:

#### **Provisional acceptance**

Full acceptance is proceeded to at the place of delivery without partial acceptance at the place of manufacture;

Provisional acceptance is carried out in full at the place of delivery. To investigate and test the supplies as well as to notify its decision to accept or reject the delivery, the contracting authority disposes of a period of thirty days

This period will begin on the day after the date of arrival of the supplies at the place of delivery, provided that the contracting authority is in possession of the delivery note or invoice. It comprises the 30-day period stipulated in Article 127.

#### 4.15.2 Transfer of ownership (Art. 132)

The contracting authority automatically becomes the owner of the supplies as soon as they have been accepted for payment pursuant to Article 127 of GIR.

## 4.15.3 Guarantee period (Art. 134)

The warranty period commences on the date on which provisional acceptance is given. **It lasts for minimum one year**.

#### 4.15.4 Final acceptance (Art. 135)

Final acceptance occurs upon expiry of the warranty period. It is implicit when the delivery has not led to any claims during said period.

If delivery has led to complaints during the warranty period, a final acceptance or refusal of acceptance report will be issued within 15 days prior to the expiry of said period.

#### 4.15.5 Acceptance costs

## 4.15.6 Invoicing and payment of services (Art. 66 to 72 - 160)

The contracting authority shall verify and pay the amount due to the supplier within the processing period of thirty days from delivery, provided that the contracting authority is in possession of the duly established invoice accompanied by the acceptance report.

The supplier sends (one copy only of) the invoices and the acceptance report (original copy) with the original lists of supplied ICS by the respective beneficiaries to the following address:

#### The invoice shall be in **euros**.

Only delivery that has been performed correctly may be invoiced. The supplier has to provide a separate invoice for each purchase order with a narrative report including in annex for the item 2 (supply of ICS) the list of beneficiaries with their ICS reception signature, the copy of the signed commitment letter from beneficiaries (see detail in section 5) and the prove of the payment of their contribution.

The amount owed to the supplier must be paid within thirty days with effect from the expiry of the verification term or with effect from the day after the last day of the verification term, if this is less than thirty days. And provided that the contracting authority possesses, at the same time, the duly established invoice and any other documents that may be required.

No advance may be asked by the supplier and the payment is made after provisional acceptance of each delivery of a same order.

## 4.16 Litigation (Art. 73)

The competent courts of Brussels have exclusive jurisdiction over any dispute arising from the performance of this public contract. French or Dutch are the languages of proceedings.

The contracting authority will in no case be held liable for any damage caused to persons or property as a direct or indirect consequence of the activities required for the performance of this contract. The supplier indemnifies the contracting authority against any claims for compensation by third parties in this respect.

## 4.17 Release of the performance bond (Art. 144)

Unless stipulated otherwise in the procurement documents, the bond can be released in one time upon final acceptance of deliveries of the same service order.

## 5 Terms of reference

# Supply of Mobile Improved Cooking Stoves (2025-2026 campaign) in the Eastern Province of Rwanda

#### 5.1 General conditions

The supplies must be new and guaranteed of origin. They must be free of any flaw or defect that could harm their appearance and proper functioning and they must comply with the 'Technical Sheets'.

The tenderer attaches the following to his tender:

- The duly completed technical forms of the supplies to be delivered
- The certificates and attestations of origin of the supplies which must be delivered at the same time as the supplies
- A working drawing or photographs of proposed Improved Cooking Stove (ICS) with all the technical specification of the stoves;
- The results of the testing done on the proposed ICS by the Rwanda Standard Board (Efficiency %, Co2 emission and particle emission)

#### 5.2 After-sales service

In his tender the tenderer will include a statement certifying that he undertakes to:

Ensure **a minimum of 1 year guarantee** on provided supplies, , ensuring its reparation/replacement in case the supply is not working properly anymore due to evident manufacturing defect.

## 5.3 Technical specifications

#### 5.3.1 Context

The Ministry of Environment, through the Rwanda Forestry Authority and with the support of partners, is implementing the TREPA project (US\$ 39M, 2022-2027) funded by the Green Climate Fund (GCF) with IUCN as Accredited Entity.

This project is focusing on the landscape restoration for adaptation of the Eastern province of Rwanda to drought, trough sustainable forest management, dissemination of agroforestry and silvopastoral technics, restoration of protective forests, dissemination of clean cooking solutions, farmers group organization, access to microfinance, support to products value chains, etc.

This project is executed by RFA, IUCN and Enabel, in collaboration with District and implementing partners (ICRAF, World Vision, Cordaid). Enabel is in charge of the component 1.5 on clean and efficient cooking energy technologies dissemination in the farmer's households supported by TREPA, to reduce biomass fuel consumption, with following activities:

- 1.5.1 Conduct a large scale and intensive awareness campaign across the Eastern Province on ICS and cooking fuel solutions and opportunities,
- 1.5.2 Support access to ICSs for over 100,000 rural/farmer's Households of EP (2023-2025)
- 1.5.3 Establish "Cooking fuel and technology" hubs in local markets
- 1.5.4. Provide feedback into enabling environment activities supporting the shift from traditional cooking to clean ICS and fuels

The targeted households for the TREPA ICS dissemination are the farmer's families involved in agroforestry/silvopastoral and woodlot/forest restoration activities undertaken under component 1.1 to 1.4 of the TREPA project, covering as well the farmers involved in the Combio sister project.

#### 5.3.2 The TREPA ICS dissemination strategy:

In this context, and in line with the Ministerial decree on Clean Cooking Technologies published by MININFRA in December 2022, the TREPA project developed in 2023 a strategy for the ICS dissemination which has been piloted and assessed during the 1<sup>st</sup> campaign of 2023-2024. Based on the first campaign experience and lessons learned, the ICS dissemination has been updated and improved, with the following key elements:

- In order to ensure that farmer access to ICS model fitting with their own households context and needs and secure/improve the real adoption and use of the ICS by beneficiaries, demonstration events have to be organised at each targeted village level (120-140 events) of the TREPA target landscapes, **bringing several models** reaching the minimum selection criteria in term of thermal laboratory efficiency and adapted to local farmers conditions. Among the proposed technologies, the 2 following are integrated into this tender:
  - Technology 1: Improved Mobile Cooking Stoves with an efficiency of more than 30%, that might be afforded by farmer at a low contribution cost;
  - Technology 2: Improved Mobile Cooking Stoves with an efficiency of more than 36% accompany with specifically sized pots and heat retaining box, which is improving overall fuel wood saving, that might be afforded by farmer at a higher contribution cost;
- Subsidize the stove to secure their affordability for targeted farmers, while avoiding free distribution as per Ministerial guidelines. The scheme have to propose a fixed amount per stove to be subsidized by the project (depending of their technology), while the farmer will contribute to the remaining cost based on the real market price of the stove he is choosing. The system used in former campaign, with a fixed contribution from farmer depending of their household category, disregarding the real cost and efficiency/appreciation from the farmers, will be avoided.
- Promote the stove locally produced in Rwanda and avoid imported model;
- By GCF regulation, the project cannot subsidized stove model who already received a
  support from carbon credit schemes. However, the project will invite the related
  company producing high level stove already subsidized by other carbon credit schemes
  in the selection process and will support their participation to the demonstration events
  at village level, so targeted farmers might purchase these models at the price offered by
  the suppliers even if not subsidized by the TREPA project but by other carbon credit
  systems;
- Several models from Tech 1 and Tech 2 might be proposed to farmer by different companies to be selected through tender process allowing multiple company selection, each of selected company getting a framework contract at their offered price. These companies will have to attend demonstration events and show case their stoves, then targeted farmer's beneficiaries from the established lists will decide by themselves the stove model they want and will pay their own contribution according to the chosen ICS

model. Once the contribution is paid, the stove is distributed by the suppliers. The project will paid the subsidy part after checking the good reception of contribution and of stoves.

- The project will avail local ICS animators to support:
  - the organisation of the demonstration event,
  - The proper establishment of the list of beneficiaries in collaboration with TREPA/Combio collaborators, local targeted cooperatives representatives and local authority.
  - The proper registration of the contribution paid by farmers for the selected stove model in collaboration with ICS suppliers,
  - o to register the reception of the stoves by beneficiaries in collaboration with local authorities,
  - o to ensure technical support/guidance to beneficiaries on how to select and use properly the stove according to their conditions
  - o to collect feedback on the use and adoption/appreciation of the stoves by beneficiaries

It is in this context that Enabel is launching this tender, for the supply of mobile Improved Cooking Stoves (of Technology 1 and Technology 2 here above) in the Eastern Province of Rwanda in 2025 and 2026.

## 5.4 Technical description of tender

#### 5.4.1 Description of the 12 lots

The lots are as followed:

#### For the stoves to be subsidised by TREPA project (lot 1 to 8)

- For the Technology 1: lot 1, lot 2, lot 3, lot 4, lot 5 and lot 6, they have the same requirement:
  - For each of the 6 lots: locally produced mobile cooking stove, with a thermal efficiency superior or equal to 30% (≥30%), accommodating wood and/or crop residues fuel.
  - For each of the 6 lots: estimative quantity of 12.000 stoves to be distributed, with a maximum quantity of 60.000 stoves
  - For each the 6 lots, the stoves have to be subsidized by the TREPA project based on scheme detailed in chapter below. The tenderer has to provide a commitment letter that the stove distributed with this TREPA subsidy support will not be used for any other carbon credit claim. The prices offered by the bidders for the stove should exclude any other carbon credit support.
- **For the Technology 2**: **lot 7 and lot 8**, they have the same requirement:
  - For each of the 2 lots: locally produced mobile high efficient cooking stove efficiency superior or equal to 36% efficiency (≥36%"), accommodating wood and/or crop residues fuel, accompanied with 2 specifically sized pots and adaptor, and 1 heat retaining box
  - For each of the 2 lots: estimative quantity of 8.000 stoves to be distributed, with a maximum of 20.000 stoves
  - For each the 2 lots, the stoves have to be subsidized by the TREPA project based on scheme detailed in chapter below. The tenderer has to provide a commitment letter that the stove distributed with this subsidy support will not be used for any other carbon credit claim. The prices offered by the bidders for the stove should exclude any other

# ➤ For the stoves already subsidized by another carbon credit system, not to be subsidized by TREPA project (lot 9 to 12)

For the lots n°9 to lot n°12, awarded tenderers will be invited to participate into the demonstration events based at a fixed unit cost per event covered, but the stove disseminated by the tenderers will not be subsidized by the TREPA project. The price offered by tenderers, which is already including the subsidy from other carbon credit scheme, will be fully paid by beneficiaries.

- For the Technology 1: lot 9 and lot 10, they have the same requirement:
  - locally produced mobile cooking stove, with a thermal efficiency superior or equal to 30% (≥30%), accommodating wood and/or crop residues fuel.
  - Affordable price to be fully paid by beneficiaries, not being distributed freely
- For the Technology 2: lot 11 and lot 12, they have the same requirement:
  - For each of the 2 lots: locally produced mobile high efficient cooking stove efficiency superior or equal to 36% efficiency (≥36%), accommodating wood and/or crop residues fuel, accompanied with 2 specifically sized pots and adaptor, and 1 heat retaining box;
  - Affordable price to be fully paid by beneficiaries, not being distributed freely.

The bidder who wants to apply for **TREPA subsidized stove of Technology 1**, has to provide one unique proposal for all the 6 Lots =lot 1, 2, 3, 4, 5 and 6, each of the lots with the same stove and same price.

The bidder who wants to apply for **TREPA subsidized stove of Technology 2**, has to provide one unique proposal for all the two Lots = lot 7 and 8, each of the lots with same stove and same price.

The bidder who wants to apply for **not subsidized stove of Technology 1**, have to provide one unique proposal for both lots 9 and 10, where each of the lots has the same stove and same price.

The bidder who wants to apply for **not subsidized stove of Technology 2**, have to provide one unique proposal for both lots 11 and 12, each of the lots with same stove and same price.

A bidder can apply only for TREPA subsidized stove (lot 1 to 8) OR only\_for not subsidized stove (lot 9 to 12), meaning that a same bidder cannot apply for both (subsidized /not subsidized).

A bidder who will submit proposals for Subsidized and non-subsidized stoves at the same time will be rejected from the tendering process.

For the TREPA subsidized stove, the same bidder can apply for Technology 1 and for Technology 2, in 2 separate envelopes (one proposal for Technology 1 with the lots 1, 2, 3, 4, 5, 6 + another separate proposal for Technology 2 with the lots 7 and 8).

For the not subsidized stove, a same bidder can also apply for both Technology 1 and for Technology 2, in separate envelopes (one proposal for Technology 1 with the lots 9 and 10) and one separate proposal for Technology 2 with the lots 11 and 12).

If a tenderer submits a tender for both technologies, the models (model to be understand in the sense of **the specific design/prototype**, not in the sense of the brand of the product) of the Improved Cooking Stoves (ICS) proposed for each of the technology **have to be different**.

# Also, the same tenderer cannot propose 2 models for 1 technology. For each technology targeted, the tenderer has to propose only one model "its best model".

For the lot 1 to 6: among the tenderers that will pass the stage of selection, the first 6 having the highest combined score (rank, 1, rank 2, rank 3, rank 4, rank 5 and rank 6) will be awarded the tender respectively for lot 1, lot 2, lot 3, lot 4, lot 5 and lot 6. Under Technology 1, one (1) tenderer can be awarded only 1 lot out of the 6 lots.

For the lot 7 and 8: among the tenderers that will pass the stage of selection, the first 2 having the highest combined score (rank, 1, rank 2) will be awarded the tender respectively for lot 7 and 8). Under Technology 2, one (1) tenderer can be awarded only for 1 lot out of the two Lots.

The same applies for the lot 9 and 10: whereby among the tenderers that will pass the stage of selection, the first 2 tenderers having the highest combined score (rank, 1, rank 2) will be awarded respectively for lot 9 and 10). Under Technology 1, one (1) tenderer can be awarded only for 1 lot.

And for the lot 11 and 12: among the tenderers that will pass the stage of selection, the first 2 tenderers having the highest combined score (rank, 1, rank 2) will be awarded respectively for lots 11 and 12). Under Technology 2, one (1) tenderer can only be awarded one (1) lot.

Note that one tenderer cannot submit more than 1 proposal in one technology, this means that any tenderer who submit his proposal as an individual company on one technology is not allowed to also submit a proposal in the same technology as member of a joint venture.

#### Each of the 12 lots consists of two (2) items, as describe below:

#### Item 1: Participation to the ICS demonstration events at community level

The project will organize 1-day demonstration event in each of the 120-140 targeted farmer beneficiary groups, in their community most appropriate villages.

During these 1-day events, the awarded tenderers (Supplier) will have to ensure the presentation by their professional technicians of their selected ICS model, with practical demonstration.

Every Supplier will be invited to the first 28 demonstration events (first purchase orders).

For the next following events, only the Supplier that have sold to targeted farmers at least more than 15 stoves per event (being subsidized by the TREPA project or not) in previous 21 demonstration event will be invited and will receive additional purchase order to participate.

The unit cost for participating to the demonstration event is fixed by the Contracting Authority to 100 Euros (VAT excluded) per 1 day event participation (lumpsum cost per 1 day event per service provider per lot, disregarding the number of persons of representatives they want to send in their team).

The following elements will be directly taken in charge (covered) by the project:

- The organization and logistic cost of the demonstration event, except the renumeration (including transport) and mission cost of Supplier's technicians who participate to these events:
- The cost of Enabel ICS animators who will support the ICS dissemination campaign

#### Item 2: supply of the selected ICS to the communities

The objective is to supply mobile efficient cooking stoves to the rural households targeted by the TREPA projects in the Eastern Province of Rwanda.

Based on the contributions paid by the registered targeted beneficiaries for their selected ICS model, the concerned Supplier will have to distribute the ICSs to these beneficiaries.

# • For lot 1, lot 2, lot 3, lot 4, lot 5, lot 6, lot 9 and lot 10 (Technology 1): supply of mobile improved cooking stove (efficiency)

The minimum requirement for this Improved Cooking Stove to be supply are as follows:

- 1. Being a mobile stove sized for a normal household, locally produced (in Rwanda);
- 2. Having an isolating part + an external metallic structure (increasing durability while avoiding hot temperature)
- 3. Accommodating fuel wood as primary fuel
- 4. With a laboratory thermal efficiency superior or equal to 30% (≥) to be proven by a testing report from RSB
- 5. Each ICS having a unique serial identifying number or code provided by the suppliers

# • For lot 7, lot 8, lot 11 and lot 12 (Technology 2): supply of very high efficient mobile cooking stove (efficiency ≥36%)) with sized pots and heat retaining box.

The minimum requirement for this Improved Cooking Stove to be supply are as follows:

- 1. Being a mobile stove sized for a normal household, locally produced (in Rwanda);
- 2. Having an isolating part + an external metallic structure (increasing durability while avoiding hot temperature);
- 3. Accommodating fuel wood;
- 4. With a laboratory thermal efficiency superior or equal to 36% (≥36%), to be proven by a testing report from RSB
- 5. Accompany with a heat retaining box and 2 pots of different sizes with adaptors, (optimizing energy transmission to the pot);
- 6. Each ICS having a unique serial identifying number or code provided by the suppliers

Note that at any time during the contract implementation, the Contracting Authority reserve the right of collecting some of the stoves (sample of 6 units per control campaign) distributed to beneficiaries to conduct laboratory testing of the thermal efficiency and verify that the stove is in the range (+- 10%) of the efficiency provided in the technical offer of the bidder. In case the average efficiency of the sample is not (lower) in the range, the Contracting Authority might request the ICS supplier to replace the distributed stove with the one having the right announced efficiency, or if this is not possible, to terminate the contract.

# 5.4.2 Targeted beneficiaries and maximum quantity

The targeted beneficiaries for the years 2024-2025 where the ICS have to be supplied are 93.000 farmers households distributed across the 7 Districts of the Eastern Province (12.000 to 15.000 household per District, with 1 ICS per household), which are the members of farmers groups targeted by the private forest and agroforestry/silvopastoral lands restoration undertaken by the TREPA project. It consists in around 120-140 groups of farmers. The TREPA project will provide the list and location of the targeted groups of farmers.

For each targeted group, the project, in collaboration with local authority, will establish the list of targeted beneficiaries. These list will serve as the basis for ICS distribution.

In each targeted group, the TREPA project will organised an ICS demonstration event in where every selected ICS suppliers will demonstrate the advantage of their ICS model, and the mandatory contribution requested from the beneficiaries (see subsidy scheme presented below) will be explained.

Every bidder awarded will be invited to the first 28 demonstration events (first purchase orders). For the next following events, only the awarded bidders that have sell to targeted farmers at least more than 20 stoves per event (being subsidizes by the TREPA project or not) in previous 28 demonstration event will be invited and will receive additional purchase order to participate. So for each of the 12 lots (n°1 to 12), minimum quantity of events for item 1 is 28, with a maximum quantity of 140.

Beneficiaries of the targeted community groups from the list will be invited to pay their contribution for their preferred chosen stove model. These contributions will be paid to special Momo account avail by the ICS suppliers specifically for this campaign (1 per stove model) and will be registered (using the same

initial list of targeted beneficiaries) with the support /supervision of one representative of the community and the Enabel ICS animator (template will be provided by the project).

Once the farmers contribution are paid, the ICS suppliers are delivering the stove to the beneficiary's contributors, and each ICS stove reception by each beneficiary is properly registered.

# The stoves have to be delivered in their respective villages within maximum 4 calendar weeks from the day of the reception of the farmer contribution.

The project local cooking technology animators will assist the awarded tenderers in the checking and proper reception of the ICS by each beneficiary in each of the village. The list of reception will be signed by each farmer beneficiary according to the initial list of contribution, indicating at the minimum:

- beneficiary full name, ID card number, phone contact, District/Sector/Cell/Village,
- the ICS model chosen,
- amount (RWF) contributed with the date and the farmers contributor signature, and with testimony signature by the representative of the ICS suppliers and by the ICS animator and/or designated community representative, indicating their names and phone contacts)
- The unique identifying number (provided by the ICS suppliers) of the received ICS
- The date of the ICS reception and signature of beneficiary and testimony

**For the TREPA subsidized stove (lot 1 to 8**), the list of contributors validated by local authorities is sent to the Contracting Authority who will deliver the Purchase Order to the awarded ICS suppliers on this basis. Once properly signed and approved by local authority representative, the lists of reception will be sent to the contracting authority. The awarded tenderer will invoice the contracting authority based on these lists of reception duly signed. Only 1 final invoice per purchase order will be proceeded. No advance instalment payment or payment for a part of a purchase order will be allowed.

#### Quantities for Item 1 (demonstration events):

For each of the 12 lots, for the item 1 related to the participation to the demonstration event, the minimum quantity that will be fixed in the 1<sup>st</sup> purchase Order is 28 events (2025, 4 events in each of the 7 Districts of the Eastern Province), with a maximum quantity of 140 (2025-2026). For the events following the first 28, only the awarded bidders that have sell to targeted farmers at least more than 15 stoves per event (being subsidized by the TREPA project or not) in previous 28 demonstration events will be invited and will receive additional purchase order to participate.

#### Quantity for Item 2 (ICS dissemination):

The tentative estimated and maximum quantities per lot are provided in the table below.

The contracting authority does not commit in any way as to quantities that will be ordered through this contract. The supplier cannot use the fact that the possibly listed quantities were not attained as a basis for claiming compensation.

#### **Preamble**

By decision of the [.....], the contractor was awarded a public contract in accordance with Tender Specifications no. [.....].

The needs of this public contract involve the processing of personal data within the meaning of the Belgian law on the protection of natural persons with regard to the processing of personal data and of European Regulation 2016/679 (GDPR).

The purpose of this amendment is to comply with the requirements of Article 28 of the GDPR.

The public contract conditions are not otherwise derogated, particularly in terms of the time frame and value of the public contract awarded.

#### **Article 1: Definitions**

1.1. Terms such as 'process'/'processing, 'personal data,' 'personal data controller', 'processor' and 'personal data breach' must be interpreted in light of data protection legislation. 'Data protection legislation' refers to any regulation of the European Union and/or its Member States, including, without being limited to laws, directives and regulations for the protection of personal data, in particular European Regulation 2016/679 on the protection of natural persons with regard to the processing of personal data and the free movement of such data (GDPR) and the Belgian law of 30 July 2018 on the protection of natural persons with regard to the processing of personal data.

#### **Article 2: Subject-matter of the Agreement**

- 2.1. During performance of the public contract, the contracting authority entrusts the contractor with the processing of personal data. The contractor undertakes to process personal data in the name of and on behalf of the contracting authority.
- 2.2. The contractor performs the public contract in accordance with the provisions of this Agreement.
- 2.3. Both Parties explicitly undertake to comply with the provisions of applicable data protection laws and to do nothing or fail to cause the other Party to violate relevant and applicable data protection laws.
- 2.4. The elements included in the processing are further included and clarified in Annex 1 of this Agreement. The following are particularly included in said Annex:
  - a) Personal data processing activities;
  - b) The categories of personal data processed;
  - c) The categories of stakeholders to which the personal data of the contracting authority's relate;
  - d) The purpose of the processing.
- 2.5. Only the personal data mentioned in Annex 1 of this Agreement may and must be processed by the contractor. In addition, personal data will only be processed in light of the purposes set out by the Parties in Annex 1 of this Agreement.

- 2.6. Both Parties undertake to take appropriate measures to ensure that personal data are not misused or acquired by an unauthorized third party.
- 2.7. In the event of a conflict between the provisions of this Agreement and those of the Tender Specifications, the provisions of this Agreement will prevail.

#### Article 3: Instructions of the contracting authority

- 3.1. The contractor undertakes to process personal data only on the documented instructions of the contracting authority and in accordance with agreed processing activities as defined in Annex 1 of this Agreement. The contractor will not process the personal data subject to this Agreement in a manner inconsistent with the instructions and provisions of this Agreement.
- 3.2. The contractor undertakes to process personal data in accordance with the documented instructions of the personal data controller, including for transfers of personal data to third countries or to international organisations, unless it is required under EU or Member State law. In this case, the processor informs the personal data controller of this legal obligation prior to processing unless the relevant law prohibits such information for important public interest reasons.
- 3.3. The contracting authority may unilaterally make limited changes to the instructions. The contracting authority undertakes to consult with the contractor before making significant changes to the instructions. Changes affecting the content of this Agreement must be agreed by the Parties.
- 3.4. The contractor undertakes to immediately notify the contracting authority if it considers that the instructions received (in whole or in part) constitute a violation of the Regulations or other provisions of EU law or Member State data protection law.

#### Article 4: Assistance to the contracting authority

- 4.1. **Legal conformity**. The contractor assists the contracting authority in accordance with its obligations under the Regulation, taking into account the nature of the processing and the information available to the contractor.
- 4.2. **Personal data breach** In the case of a personal data breach in relation to processing under this Agreement, the contractor must without undue delay after having become aware of it notify the personal data breach to the contracting authority.

At the very least, this notification should include the following information:

- (a) Nature of the personal data breach
- (b) The categories of personal data
- (c) The categories and approximate number of data subjects concerned
- (d) The categories and approximate number of personal data records concerned
- (e) The likely consequences of the personal data breach
- (f) The measures taken or proposed to be taken by the contractor to address the personal data breach, including, where appropriate, measures to mitigate its possible adverse effects.

The contractor is required to remedy the negative consequences of a data breach as quickly as possible or to minimise other potential consequences. The contractor will immediately implement all remedies requested by the contracting authority or the relevant authorities to

remedy any data breach or other non-compliance and/or mitigate the risks associated with these events. The contractor will have to cooperate at all times with the contracting authority and observe its instructions in order to enable it to carry out an appropriate investigation into the data breach, formulate a correct response and then take appropriate action.

4.3. **Data protection impact assessment** Where applicable and where requested by the contracting authority, the contractor assists the contracting authority in carrying out the data protection impact assessment in accordance with Article 35 of the Regulation.

#### Article 5: Obligations of the contractor/processor

- 5.1. The contractor will deal with all reasonable requests from the contracting authority for the processing of personal data related to this Agreement, immediately or within a reasonable period of time (based on the legal obligations set out in the Regulation) and in an appropriate manner.
- 5.2. The contractor guarantees that there is no obligation arising from any applicable legislation that makes it impossible to comply with the obligations of this Agreement.
- 5.3. The contractor maintains complete documentation, in accordance with the law or regulations applicable to the processing of personal data carried out for the contracting authority. In particular, the contractor must keep a record of all categories of processing activities carried out on behalf of the contracting authority in accordance with Article 30 of the GDPR.
- 5.4. The contractor undertakes not to process personal data for any purpose other than the performance of the public contract and the fulfilment of the responsibilities of this Agreement in accordance with the documented instructions of the contracting authority; if the contractor, for whatever reason, cannot comply with this requirement, he will notify the contracting authority without delay.
- 5.5. The contractor will immediately inform the contracting authority, if he believes that an instruction by the contracting authority violates applicable data protection legislation.
- 5.6. The contractor will ensure that personal data are disclosed only to those who need it to perform the public contract in accordance with the principle of proportionality and the principle of "need to know" (i.e. data are provided only to persons who need personal data to perform the public contract as determined in the relevant Tender Specifications and this Agreement).
- 5.7. The contractor undertakes not to disclose personal data to persons other than contracting authority personnel who require personal data to comply with the obligations of this Agreement and ensures that identified staff have accepted appropriate legal and contractual confidentiality obligations.
- 5.8. If the contractor is in breach of this public contract and the GDPR by determining the purposes and means of processing, he should be considered a personal data controller in the context of such processing.

#### **Article 6: Obligations of the contracting authority/controller**

- 6.1. The contracting authority will provide all necessary assistance and cooperate in good faith with the contractor to ensure that any processing of personal data is in accordance with the requirements of the Regulation, including the principles relating to the processing of personal data.
- 6.2. The contracting authority will agree with the contractor on the appropriate channels of communication to ensure that instructions, guidance and other communications

regarding personal data that are processed by the contractor on behalf of the contracting authority are well received between the Parties. The contracting authority notifies the contractor of the identity of the single point of contact of the awarding authority that the contractor is required to contact under this Agreement. Unwritten instructions (e.g. oral instructions by telephone or in person) must always be confirmed in writing.

- 6.3. The contracting authority guarantees that it will not issue any instructions, guidance or requests to the contractor who does not comply with the provisions of the Regulation.
- 6.4. The contracting authority provides the necessary assistance to the contractor and/or his or her subsequent subcontractors to comply with a request, order, investigation or subpoena addressed to the contractor or his subsequent subcontractor(s) by a competent government or judicial authority.
- 6.5. The contracting authority guarantees that it will not instruct, guide or ask the contractor to compel the contractor and/or his subsequent subcontractor(s) to violate any obligation imposed by the applicable mandatory national legislation to which the contractor and/or his subcontractor(s) are subject.
- 6.6. The contracting authority ensures that it will cooperate in good faith with the contractor in order to mitigate the negative effects of a security incident affecting the personal data processed by the contractor and/or his subsequent contractor(s) on behalf of the contracting authority.

#### Article 7: Use of subsequent subcontractors/processors

- 7.1. In accordance with the Tender Specifications, the contractor may use the capacity of a third party to tender for the public contract, which constitutes further subcontracting within the meaning of Article 28 of the GDPR.<sup>34</sup>.
- 7.2. The contractor may engage another subcontractor (hereinafter, the 'subsequent subcontractor') for carrying out specific processing activities. In this case, he informs the contracting authority in advance and in writing of any change considered with regards to adding or replacing other subcontractors. This information must clearly indicate the processing activities that are subcontracted, the identity and contact details of the subcontractor and the dates of the subcontracting contract. The contracting authority disposes of 30 days from the date of reception of said information to voice any objections. Such subsequent subcontracting may only be carried out if the contracting authority has not voiced any objection during said period.
- 7.3. The contractor will use only subsequent subcontractors who provide sufficient guarantees to implement appropriate technical and organisational measures in such a manner that the processing will meet the requirements of this public contract, of Belgian legislation and of the GDPR and assures the rights of the data subject concerned.
- 7.4. When the contractor uses another subcontractor to carry out specific processing activities in the name of the contracting authority, obligations in any respect identical to those provided for in this Agreement will have to be imposed on this subsequent subcontractor; the latter in particular must provide the same sufficient guarantees to implement

- 7.5. Where the subcontractor fails to fulfil his data protection obligations, the contractor shall remain fully liable to the contracting authority for the performance of that subsequent subcontractor's obligations.
- 7.6. The contractor must pass on the specific objectives and instructions issued by the contracting authority in a precise and timely manner to the subsequent subcontractor(s) when and where these objectives and instructions relate to the part of the processing in which the subsequent subcontractor(s) is or are involved.

#### Article 8: Rights of the data subject concerned

- 8.1.   - The contractor will immediately inform the contracting authority of any request made by a data subject concerned relating to personal data that the contractor and/or his subsequent subcontractor(s)s are processing on behalf of the contracting authority;
  - The contractor will comply promptly and require his subsequent subcontractor(s) to promptly comply with any request from the contracting authority to comply with a request by the data subject concerned to exercise one of their rights;
  - The contractor will ensure that he and his subsequent subcontractor(s) have the technical and organisational capabilities to block access to personal data and to physically destroy the data without the possibility of recovery if and when such a request is made by the contracting authority. Without prejudice to the above, the contractor retains the opportunity to consider whether the request of the contracting authority does not constitute a violation of the Regulation.
- 8.3. The contractor must, at the request of the contracting authority, provide all necessary assistance and provide all necessary information for the contracting authority to defend its interests in any proceeding judicial, arbitral or otherwise brought against the contracting authority or its staff for any violation of the fundamental rights to privacy and the protection of the personal data of the data subjects concerned.

#### **Article 9: Security measures**

- 9.1. Throughout the duration of this Agreement, the contractor must have appropriate technical and organisational measures in place to ensure that the processing meets the requirements of the Regulation and ensures the protection of the rights of the data subject concerned.
- 9.2. The contractor undertakes to implement appropriate technical and organisational measures to ensure a level of security appropriate to the risk, in accordance with Article 32 of the Regulation.

- 9.3. In assessing the appropriate level of security account shall be taken in particular of the risks that are presented by processing, in particular from accidental or unlawful destruction, loss, alteration, unauthorised disclosure of, or access to personal data transmitted, stored or otherwise processed.
- 9.4. The parties recognise that security requirements are continually evolving and that effective security requires frequent assessment and regular improvement of outdated security measures. The contractor will therefore have to continually assess and strengthen, complete or improve the measures implemented with a view to the continued compliance of his obligations.
- 9.5. The contractor provides the contracting authority with a complete and clear description, in a transparent and understandable manner, of how he handles its personal data (Annex 3).
- 9.6. In the event that the contractor changes the security measures applied, the contractor undertakes to notify so immediately to the contracting authority.
- 9.7. The contracting authority reserves the right to suspend and/or terminate the public contract, where the contractor can no longer provide appropriate technical and organisational measures regarding processing risks.

#### **Article 10: Audit**

- 10.1. The contractor acknowledges that the contracting authority falls under the supervision of one or several Supervisory Authorities. The contractor acknowledges that the contracting authority and any Supervisory Authority concerned will have the right to conduct an audit at any time, and at least during the contractor's regular office hours, during the term of this Agreement in order to assess whether the contractor complies with the Regulation and the provisions of this Agreement. The contractor provides the necessary cooperation.
- 10.2. This auditing right may not be used more than once in a calendar year, unless the contracting authority and/or the Supervisory Authority has reasonable grounds to assume that the contractor is acting in conflict with this Agreement and/or the provisions of the Regulation. The restriction of the right of control does not apply to the Supervisory Authority.
- 10.3. At the written request of the contracting authority, the contractor will provide the contracting authority or the relevant Supervisory Authority with access to the relevant parts of the contractor's administration and to all places and information of interest to the contractor (as well as, applicable to those of its agents, subsidiaries and subsequent subcontractors) to determine whether the contractor complies with the Regulation and provisions of this Agreement. At the request of the contractor, the parties concerned agree to a confidentiality agreement.
- 10.4. The contracting authority must take all appropriate measures to minimise any obstruction caused by the audit on the day-to-day functioning of the contractor or the services performed by the contractor.
- 10.5. If there is agreement between the contractor and the contracting authority on a significant breach in compliance with the Regulation and/or the Agreement, as reported in the audit, the contractor will remedy this breach as soon as possible. Parties may agree to put in place a plan, including a timetable for implementing the plan, to address the gaps revealed by the audit.

10.6. The contracting authority will cover the costs of any audit carried out within the meaning of this article. Without prejudice to the above, the contractor will bear the costs of his employees. However, where the audit has revealed that the contractor is clearly not in compliance with the Regulation and/or provisions of this Agreement, the contractor bears the costs of said audit. The costs of re-compliance with the Regulation and/or the provisions of this Agreement are borne by the contractor.

#### **Article 11: Transfers to third parties**

- 11.1. The transmission of personal data to third parties in any way is in principle prohibited, unless required by law or if the contractor has obtained explicit authorisation from the contracting authority to do so.
- 11.2. In the event that a legal obligation applies to the transfer of personal data, which is the subject of this Agreement, to third parties, the contractor shall inform the contracting authority before the transfer.

#### **Article 12: Transfer outside the EEA**

- 12.1. The contractor will process personal data from the contracting authority only in a location in the EEA.
- 12.2. The contractor shall not process or transfer the personal data of the contracting authority, or process them himself or through third parties, outside the European Union, unless after express and explicit prior authorisation from the contracting authority.

The contractor will have to ensure that no access to the personal data of the contracting authority by a third party in any way leads to the transfer of these data outside the European Union.

#### Article 13: Behaviour towards national government and judicial authorities

13.1. The contractor will immediately notify the contracting authority of any request, injunction, investigation or subpoena of a competent national government or judicial authority addressed to the contractor or its subsequent subcontractor(s) that involves the disclosure of personal data processed by the contractor or a subsequent subcontractor for and on behalf of the contracting authority or any data and/or information relating to that processing.

#### Article 14: Intellectual property rights

14.1. All intellectual property rights relating to personal data and databases containing such personal data are reserved for the contracting authority, unless otherwise agreed between the Parties.

#### **Article 15: Confidentiality**

- 15.1. The contractor undertakes to guarantee the confidentiality of personal data and of their processing.
- 15.2. The contractor ensures that employees or subsequent subcontractors authorised to process personal data have committed to conducting the processing confidentially and are also bound by a contractual obligation of confidentiality.

#### **Article 16: Liability**

16.1. Without prejudice to the public contract, the contractor is only liable for the damage caused by the processing if he has not complied with the obligations of the Regulation specifically for subcontractors or if he acted outside or contrary to the legal instructions of the contracting authority.

- 16.2. The contractor is liable for the payment of administrative fines resulting from a violation of the Regulation.
- 16.3. The contractor will be exempt from liability only if he can prove that he is not responsible for the event that caused a violation of the Regulation.
- 16.4. If it appears that the contracting authority and the contractor are responsible for the damage caused by the processing of personal data, both Parties will be liable and will pay damages, in accordance with their individual share of liability for the damage caused by the processing.

# **Article 17: End of contract**

- 17.1. This Agreement applies as long as the contractor processes personal data in the name and on behalf of the contracting authority under this public contract. If the public contract ends, this Agreement will also end.
- 17.2. In the event of a serious breach of this Agreement or the applicable provisions of the Regulation, the contracting authority may order the contractor to terminate the processing of personal data with immediate effect.
- 17.3. In the event of termination of the Agreement, or if the personal data are no longer relevant to the provision of services, the contractor will, by decision of the contracting authority, remove all personal data or return them to the contracting authority and delete personal data and other copies. The contractor will provide proof in writing, unless applicable legislation requires the storage of personal data. Personal data will be returned to the contracting authority free of charge, unless otherwise agreed upon.

#### **Article 18: Mediation and competence**

- 18.1. The contractor agrees that if the data subject concerned alleges claims for damages under this Agreement, the contractor will accept the decision of the data subject concerned:
  - To refer the dispute to mediation with an independent person
  - To refer the dispute to the courts of the place of establishment of the contracting authority
- 18.2. The Parties agree that the choice made by the data subject concerned will not infringe on the substantial or procedural rights of the data subject concerned to seek redress in accordance with other provisions of applicable national or international law.
- 19.1. Any dispute between the Parties over the terms of this Agreement must be brought before the appropriate courts, as determined in the main agreement.
