

## **Addendum n°1 to the tender document (TD) for public contract for the Supply of 3 Fully Equipped and Functioning refurbished Mobile digital labs - BEL23004-10037.**

With reference to the tender launched on **15th April 2025**, and in relation to **section 3.3** (Information), **section 3.4.4** (Element included in the Price), **section 3.4.5** (How to submit the tenders), **section 4.10.3** (Place where the supplies must be delivered and formalities (Art. 49), **section 4.13.5** (Invoicing and Payment), **section 5.2.4** (Time and place of delivery), and **section 6.2** (Tender Price Form) of the tender document, please find below corrections resulting from internal review and feedback received:

### **1. Amendment – Information regarding Questions**

**Amends:** Section 3.3

The original clause stated:

“Until 10 days before the final date of receipt of tenders, candidate-tenderers may ask questions about these Tender Specifications and the public contract. Questions will be in writing to **Mr Alern Mgeni**, address [alern.mgeni@enabel.be](mailto:alern.mgeni@enabel.be) and they will be answered in the order received. The complete overview of questions asked will be available at [www.enabel.be](http://www.enabel.be) as from **6<sup>th</sup> May 2025**.”

This is hereby amended as follows:

“Until 10 days before the final date of receipt of tenders, candidate-tenderers may ask questions about these Tender Specifications and the public contract. Questions will be in writing to Mr Alern Mgeni, address [alern.mgeni@enabel.be](mailto:alern.mgeni@enabel.be) and they will be answered in the order received. The complete overview of questions asked will be available at [www.enabel.be](http://www.enabel.be) as of **16<sup>th</sup> May 2025**.”

### **2. Amendment - Invoicing and Payment**

**Amends:** Section 4.13.5

The original clause stated:

“No advance may be asked by the contractor, and the payment is made after provisional/final acceptance of each delivery of a same order.”

This is hereby amended as follows:

“An **advance payment of up to 20%** of the total contract value may be requested by the contractor. The remaining 80% shall be paid after provisional acceptance of the delivery.”

This amendment is intended to support the supplier in financing upfront investment, especially given the nature of the supply and assembly requirements.

### 3. Amendment – Submission Deadline

**Amends:** Section 3.4.5

The original clause stated:

“The tenderer submits his tender as follows:

One original copy of the completed tender will be submitted on paper. Moreover, the tenderer shall attach the copies requested by the tender guidelines to the tender (see Part 3.4.1) These copies may be submitted in one or more PDF files on a USB stick before **15th May 2025 at 4:00pm EAT.**

It is submitted in a properly sealed envelope bearing the following information: Tender **BEL23004-10037 Supply of 3 Fully Equipped and Functioning refurbished Mobile digital labs NOT TO BE OPENED BEFORE 14th May 2025 at 4:00pm EAT.**

This is hereby amended as follows:

“The tenderer submits his tender as follows:

One original copy of the completed tender will be submitted on paper. Moreover, the tenderer shall attach the copies requested by the tender guidelines to the tender (see Part 3.4.1) These copies may be submitted in one or more PDF files on a USB stick before **23rd May 2025 at 4:00pm EAT.**

It is submitted in a properly sealed envelope bearing the following information: Tender **BEL23004-10037 Supply of 3 Fully Equipped and Functioning refurbished Mobile digital labs NOT TO BE OPENED BEFORE 23rd May 2025 at 4:00pm EAT.**”

### 4. Amendment – Delivery to Final Destination

**Amends:** Sections 3.4.4, 4.10.3, 5.2.4, 6.2

The Incoterms referenced in the tender document are hereby amended from CIF to **DAP Kigoma**. Under the revised terms, the Contracting Authority shall remain responsible for customs clearance upon arrival of the goods in Tanzania, while the supplier shall be responsible for the transportation of the goods to the final destination in Kigoma. The supplier shall ensure that delivery to Kigoma is completed within forty-eight (48) hours from the date of customs clearance of the consignment.

Furthermore, bidders shall submit their financial offers using the **updated Tender Price Form** annexed to this addendum. The updated form reflects the revised Incoterms and includes a separate row for bidders to indicate the transportation cost to the final delivery location in Kigoma.

## Annex I

### 6.2 Tender form - Prices

By submitting this tender the tenderer commits to performing this public contract in conformity with the provisions of the Tender Specifications/ – and explicitly declares accepting all conditions listed in the Tender Specifications and renounces any derogatory provisions such as his own general sales conditions.

The unit prices and the global prices for each item in the inventory are established relative to the value of these items in relation to the total value of the tender. All general and financial costs as well as the profits are distributed between the various items in proportion to their weight.

The Contracting authority will handle clearance and that transport from entry point to final destination should be done within 48 hours of consignment clearance
