Following feedback and input received regarding the tender documents, please note the following amendment:

### 1. Person days

#### **Amendment to Section 6.3 (Tender forms - prices)**

The tender documents previously referred to a maximum of **164 person-days**.

This figure was the result of a clerical error. Following internal review and in alignment with Section 5.5 "Key Deliverables and Payment Schedule", the correct total is **216 person-days**. The tender documents have therefore been amended to reflect this correction (see below).
