

ADDENDUM N°1 to the TD for "Supply of Construction materials for Boys WASH Facilities" – TZA22003-10488.

With reference to the above-mentioned tender which was launched on **24**th **October 2025** and with reference to **sections 3.4.5**, **5.2.3**, **6.3** and **6.4** of the tender document.

1. Section 3.4.5 – How to Submit a Tender

Due to submission challenges arising from election-related disruptions, we hereby amend the original submission deadline stated in the tender document from 5th November 2025 at 4:00 PM EAT to 10th November 2025 at 12:00 PM (noon) EAT.

Please find below the revised section of the tender document:

One original copy of the completed tender will be submitted on paper. Moreover, the tenderer shall attach the copies requested by the tender guidelines to the tender (see Part 3.4.1). These copies must also be submitted in one or more PDF files on a USB stick before 11/11/2025 at 12:00 PM EAT.

It is submitted in a properly sealed envelope bearing the following information: Tender

- Lot 1. TZA22003-10488 Supply of Construction Materials for boys WASH Facilities-KIGOMA NOT TO BE OPENED BEFORE 10/11/2025 at 12:00pm EAT.
- Lot 2. TZA22003-10488 Supply of Construction Materials for boys WASH Facilities-KASULU NOT TO BE OPENED BEFORE 10/11/2025 at 12:00pm EAT.

Please ensure that if you are applying for 2 lots, you submit 2 separate envelopes (one for each lot).

2. Section 5.2.3 - Delivery Locations

Please find below a clarification regarding the delivery locations:

The selected supplier(s) shall deliver equal quantities of materials to each of the ten (10) schools per lot. The quantities and the names of the schools are listed in the blank Bills of Quantities (BoQs) attached to the tender document.



3. Section 6.3 - Technical Offer

Please find below a minor correction:

- Original clause:
 - Column 3 shows the required specifications (which should not be modified by the tenderer)
 - o Column 4 is to be filled in by the tenderer and must detail what is being offered (simply indicating the words "compliant" or "yes" is not sufficient).
- Amended clause:
 - Column 2 shows the required specifications (which should not be modified by the tenderer)
 - Column 4 shall be completed by the tenderer and must clearly describe the specifications of the items being offered. Only indicating 'compliant', 'yes', or copying the required specifications is not sufficient. Pease indicate the proposed specifications for each item.

4. Section 6.4 - Tender form - Prices

Please find below a minor correction:

- Original clause: Attention! The tenderer must complete and attach the Price-Schedule (BOQ) to Form 6.3.
- Amended clause: Attention! The tenderer must complete and attach the Price-Schedule (BOQ) to Form 6.4.

All other provisions of the original tender documents remain unchanged and in full effect.
